DISCUSSION:

Advisory Council members are appointed by the Board as required by the DDHS Title X Family Planning Program in which the District serves as lead agency for local administration of federal family planning funds.

Council membership consists of three representatives from the District and one each from its two subgrantees (Planned Parenthood of Rocky Mountains, acting on behalf of its local subsidiary, Planned Parenthood of Southern Nevada and the Huntridge Teen Clinic). Names of prospective members proposed by the subgrantee agencies are attached.

The purpose of council membership is: 1) to advise staff and the Board on matters concerning the consolidated program for Clark County; 2) to encourage cooperative efforts among participants in the grant; 3) to participate in evaluating the effectiveness of the program; 4) to facilitate provider and consumer input on family planning issues and 5) to meet, as needed, to review activities.
