







DISCUSSION:

Clark County Social Service seeks continued provision of HIV/AIDS Evaluation services to clients referred to the District for that purpose. The District's services include Immune Competence Profile (T-cell count) with complete blood count (CBC) as ordered by District's HIV/AIDS Evaluation Clinic physician.

Reimbursement to the District will be made by the County at the same rates charged HIV/AIDS patients for the period July 1, 2009 through June 30, 2010.

FUNDING:

The District will be reimbursed an annual amount up to \$7,500 for services provided under this agreement.

AMENDMENT NUMBER 2
To
INTERLOCAL AGREEMENT For
HIV/AIDS EVALUATION SERVICES

This Amendment Number 2 to the Interlocal Agreement is made and entered into this 21st day of April, 2009, by and between CLARK COUNTY (hereinafter referred to as COUNTY) on behalf of the CLARK COUNTY Department of SOCIAL SERVICE (herein after referred to as CCSS) and the SOUTHERN NEVADA HEALTH DISTRICT (hereinafter referred to as HEALTH DISTRICT).

WHEREAS, COUNTY and HEALTH DISTRICT entered into an Interlocal Agreement on June 6, 2007, to provide HIV/AIDS evaluation services to CCSS clients referred for that purpose; and

WHEREAS, COUNTY and HEALTH DISTRICT entered into Amendment Number 1 to the Agreement on June 17, 2008, to renew and extend the Agreement through June, 30, 2009; and

WHEREAS, the Interlocal Agreement, unless it is extended, expires on June 30, 2009; and

WHEREAS, Section III, Paragraph 17, of the Interlocal Agreement provides the option to renew the Interlocal Agreement for 3 one-year periods, upon approval by the parties; and


WHEREAS, COUNTY and HEALTH DISTRICT desire to continue the Interlocal Agreement.

NOW, THEREFORE, COUNTY and HEALTH DISTRICT hereby agree to exercise the second of three (3) one-year options to renew and extend the term of the Interlocal Agreement from July 1, 2009, through June 30, 2010.
