	Core objectives:
Key Responsibilities:	 Foster openness and participatory nature of the community planning process. Ensure the community planning group(s) reflects the diversity of the epidemic in the jurisdiction, and that expertise in epidemiology, behavioral/social science, health planning, and evaluation are included in the process. Ensure priority HIV prevention/care needs are determined based on an epidemiological profile and needs assessment. Ensure interventions are prioritized based on explicit consideration of priority needs, outcome effectiveness, cost and cost effectiveness, theory, community norms and values. Foster strong, logical linkages between the community planning process, application for funding, and allocation of CDC HIV prevention/care resources.
	is to: 1. Elect a community co-chair to work with the co-chair designated by the health district.
	 Determine the technical assistance needs of the community planning group to enable it to execute an effective community planning process.
	3. Carefully review available epidemiology, evaluation, behavioral and social science, cost and cost-effectiveness, needs assessment, and resource inventory data and other information required to identify and prioritize HIV prevention/care needs.
	4. Identify unmet HIV prevention/care needs within defined populations.
	5. Prioritize HIV prevention/care needs by target populations and by priority strategies and interventions.

	6. Identify the technical assistance needs of the community planning group and community-based providers in the areas of planning, implementing, and evaluating prevention/care interventions.
	7. Assess how well the priorities outlined in the plan are represented in the health department's application to CDC for federal HIV prevention funds and Ryan White Title II funds .
	8. Focus primarily on the tasks of planning. Develop a comprehensive HIV prevention/care plan that is responsive to the changing community needs and epidemic
	9. Review carefully the health department's application to CDC for federal HIV prevention funds and Ryan White Title II funds, including the proposed budget, and a letter of concurrence or nonconcurrence.
