UST REMOVAL REGULATORY AND SNHD ADMINISTRATIVE PROCEDURES

The following information has been developed to provide some basic guidelines to applicants for Underground Storage Tank (UST) removals within Clark County. Please review the information carefully and assure that your firm is operating within these provisions.

40 CFR §280.71 - "Permanent Closure and Changes in Service" adopts API-RP 1604 as a standard for compliance for cleaning and closure of USTs. Individuals that are not complying with these recommendations are subjecting themselves to significant liability should an accident or injury occur.

40 CFR §280.71 requires thirty (30) days notice prior to beginning an UST closure. Southern Nevada Health District (SNHD) must have at least 48-hour notice prior to tank removal.

40 CFR §280.72 requires that a site assessment to measure for a release where contamination is most likely to be present must be conducted before permanent closure is complete. SNHD has determined this means that assessment must be conducted for tanks, piping and dispensers.

40 CFR §280, Subparts F & G addresses Release Response and Corrective Action and UST Closure.

NAC 459.996 & 445A.347 provides direction for reporting releases in the State of Nevada.

NAC 459.9971, .9972, & .9973 outlines Nevada procedures for soil sampling, analysis and corrective action for UST permanent closure.

NAC 459.9974 provides instructions for disposal of contaminated soil.

NAC 459.9975 provides guidance on monitoring ground water.

Please note, in order to close this permit, SNHD must receive, review and approve a permanent closure report with the following information:

- 1. Documentation verifying that the UST was compliant with State and Federal leak detection regulations at and prior to the date of closure;
- 2. Laboratory analysis results of soil (as required by NAC 459.9972 and 40 CFR 280.72);
- 3. Field screening or laboratory results of other suspect soil contamination areas (lines, dispensers, stains, etc.);
- 4. Documentation of the final disposition of any excavated contaminated soil;
- 5. Documentation of the final disposition of all other solid waste materials (tanks, lines, components, etc.);
- 6. Documentation of the final disposition of liquid materials (contents, rinsate, groundwater, etc.);
- 7. Documentation that the tanks have been triple rinsed;
- 8. Documentation that the tanks have been inerted or purged for flammable vapors and subsequently tested to verify that the tanks, lines and equipment were removed and transported in accordance with the Uniform Fire Code 79.115(d), API 1604, and all other pertinent State and Federal environmental and transportation regulations.
- 9. Updated US EPA Form 7530-1, Notification for Underground Storage Tanks, indicating permanent UST closure.
- 10. Narrative describing tank closure activity and significant findings: and
- 11. Confirmation whether or not a reportable release occurred as required by NAC 445A.347, 40 CFR 280.50 & .53, NAC 459.9973, & 40CFR261-TCLP.
