## **Pool Signs**

- 1. "NO SWIMMING, BATHING OR OTHER USE OF FACILITY ALLOWED AFTER DARK," in contrasting letters, at least 4 inches in height, posted near each entrance to the facility or bathing place. (NAC 444.142) Required if inadequate underwater lighting or area lighting.
- 2. "NO DIVING" in contrasting letters, at least **4 inches** in height, posted in a conspicuous place. (NAC 444.116)
- 3. "WARNING NO LIFEGUARD ON DUTY" with clearly legible letters, at least 4-inches in height. (NAC 444.276)
  - A. "Children Under 14 Years Old Should Not Use Facility Without An Adult in Attendance" required if no lifeguards are on duty. (NAC 444.276)
  - B. "Solo Bathing is Prohibited." required if no lifeguards are on duty. (NAC 444.276)
- 4. **Pool Operator Information** (NAC 444.268) (SNHD "Regulations Governing the Certification of Swimming Pool Service Companies, Technicians, Technician Apprentices, and Pool Operators in Clark County 3.1.6 & 7.5)
- 5. **CPR Instructions** (NAC 444.268)
- 6. **911/Emergency Numbers** posted inside enclosure. (NAC 444.268)
- 7. **Pool Rules** (NAC 444.258)
- **8. Capacity** (NAC 444.278)

## **Spa Signs**

- 1. A sign with at least **4-inch** letters on a contrasting background must be posted near the spa which indicates that **CHILDREN 12 YEARS OF AGE OR YOUNGER MUST BE SUPERVISED BY AN ADULT** and that **THE MAXIMUM RECOMMENDED TIME FOR SUCH CHILDREN TO USE THE SPA IS 10 MINUTES.** (NAC 444.526)
- 2. Extended exposure to the hot water or vapors may be detrimental to the health of persons with heart conditions. (NAC 444.524)
- 3. A sign must be posted in <u>the immediate vicinity</u> of the spa, stating the **location of the nearest telephone** with the information that emergency telephone numbers are posted on or near the telephone. (NAC 444.530)
- 4. **Pool Operator Information** (NAC 444.268) (SNHD "Regulations Governing the Certification of Swimming Pool Service Companies, Technicians, Technician Apprentices, and Pool Operators in Clark County 3.1.6 & 7.5)
- 5. **911/Emergency Numbers** on or near telephone (NAC 444.530)
- **6. Pool Rules** (NAC 444.530)
- 7. **Capacity** (NAC 444.534)
