Choose Your Level of MRC Involvement

In a few months, existing and new Medical Reserve Corps (MRC) volunteers in Nevada will be provided the opportunity to choose their level of involvement/commitment based on their personal availability and preference. Nevada’s four MRC unit coordinators and the Nevada State Health Division are currently developing the details of the level options. Following are the proposed levels, as of the date of this newsletter:

Option 1: State or Federally Declared Emergencies ONLY*

This option applies to licensed/certified health care professionals only.

Option 2: State, Federal and Local Responses

- State or federally declared emergencies*
- Local/regional emergencies
- Local public health initiatives (i.e., immunization clinics)
- Community events (i.e., health fairs, first aid support)

Option 3: Local Responses Only

- Local/regional emergencies
- Local public health initiatives (i.e., immunization clinics)
- Community events (i.e., health fairs, first aid support)

Keep in mind that state and federally declared emergencies afford professional liability coverage beyond the volunteer’s personal coverage or the Worker’s Compensation and civil liability coverage provided by the Southern Nevada Health District to MRC volunteers.

Respirator Fit Testing for Volunteers

When responding to natural or manmade disasters, responders at times are required to wear respirators to prevent exposure or inhalation of harmful fumes or particles.

As a registered volunteer with Medical Reserve Corps, you need to be "fitted" for a N95 mask. The Southern Nevada Health District's public health preparedness nurse, Dale Klabacha, performs fit tests on employees and



volunteers with respirators through our respiratory protection program. The health district stocks two types of respirators for its employees and volunteers: N95 masks and PAPR (Powered Air Purifying Respirator) hoods (*modeled in photo*).

In a situation requiring responders to wear a respirator, employees or volunteers will be required to wear the PAPR hood unless they have been fitted with an N95 mask.

The annual fit testing takes about one -and-a-half hours and is done at the health district. If you would like be fitted with an N95 mask, call Dale at 759-0870 to schedule an appointment. Be sure to mention that you are an MRC volunteer.
