I. CALL TO ORDER - NOTICE OF POSTING OF AGENDA

Member X. Foster explained what the grant was for and what it would do. The grant is for three (3) years and will help clients to get back into care. The main focus is positive clients; however testing is also part.

B. <u>PrEP CONFERENCE:</u>

Member J. Montgomery spoke about the "Biomedical Conference." Here in Las Vegas there are about 5 providers that administer PrEP however if you go on PrEP locator.org will show all the places that have PrEP.

Chair C. Radeloff asked if there is increased PrEP availability & struggles?

Member J. Montgomery stated that FSA to help lower the costs. Some insurances will cover. Undocumented immigrants only need an address to get PrEP.

Member A. Jackson stated that the cost at Huntridge is covered by Medicaid.

Member J. Montgomery stated that Gilead will pay up to \$4800 for PrEP however won't pay for labs.

Member C. Martinez stated that some clients are deciding how to go off and on PrEP per their life style.

Member J. Montgomery stated that clients have to stay on PrEP for a certain time frame in order for it to be effective.

Member R. Castillo stated that as far as the small doctor offices are concerned, education is very important.

C. SYRINGE EXCHANGE & TRACB:

Member A. Jackson stated that Huntridge was having problems with the needle vending machines. They are being used a lot.

Chair C. Radeloff stated that TracB has given out 10,000 clean needles in less than 1 year.

Member R. Thurmond asked how clients obtain new syringes?

Member C. Martinez asked how a client would use the vending machines?

Member J. Montgomery stated that a client would sign up and get a card to use the machines.
