Clark County Health District's Air Pollution Control Division Issues Penalties for the Month of September

(Las Vegas, Nev. – October 5, 1999) – During the month of September the Air Pollution Control Division (APCD) of the Clark County Health District (CCHD) issued a total of \$182,100 in penalties for violations of air pollution control regulations. Penalties totaling \$2,000 and above are reported.

Heavy Duty Construction LLC, Nevada received a penalty in the amount of \$6,000 for failing to comply with a Corrective Action Order (CAO), and for allowing fugitive dust emissions to be generated by haul trucks, buses and private vehicles traveling over trackout at its residential development, Sutter Creek. The development is located at the corner of Allen Lane and Colton Avenue.

Pulte Homes was assessed a penalty in the amount of \$6,000 for failure to stabilize the topsoil and for failure to control fugitive dust emission on its residential project, Stone Mountain, which is located on the southeast corner of Cabana Drive and Desert Inn Road.

Cactus Sand and Gravel Services, also known as Impact Sand and Gravel, received a penalty of \$4,000 for allowing fugitive dust emissions to be

generated from vehicular traffic and from a large stockpile at their 85-acre flood detention basin project. The project is located near Silverado Ranch Boulevard and Maryland Parkway.

PCL Civil constructors, Inc. was penalized for failure to comply with Dust Control Permit conditions and for failure to control fugitive dust generated by construction activities at their 23-acre public works storm drainage channel project, known as the Lower Blue Diamond Channel. The project is located between W. Russell Road and W. Quail Avenue. A penalty in the amount of \$4,000 was assessed.

Mesquite Vistas, LLC received to violations for failing to acquire valid Dust Control Permits for their developments, Rancho Santa Barbara, located at Rancho Santa Barbara Drive and Redd Hills Parkway and Lakeridge, located at Lakeridge Drive and Redd Hills Parkway. They were assessed penalties in the amount of \$3,200 and 2,500, respectively.

Pulte Home Corporation, Nevada was penalized \$2,500 for failure to have a gravel pad and for allowing fugitive dust emissions to be generated by haul trucks originating at its residential development which is located at the northeast corner of Town Center Drive and Park Run Drive.

Topolewski America Inc. was penalized \$2,300 for failure to abide by Dust Control Permit conditions on its development called Champion Village Apartments located on Stephanie Street and Lake Mead Drive.

Del Webb Coventry Homes of Nevada was assessed a penalty in the amount of \$2,300 for allowing fugitive dust emissions to be generated from construction work

at its 87 acre development called Anthem Coventry units 3, 4, and 5. The units are located on S. Eastern Avenue.

Hanson Aggregates, (also known as Bonanza Materials, Inc.) was penalized for failure to report an upset/breakdown, failure to comply with permit conditions and for allowing fugitive dust emissions from the baghouse structure at their concrete batch plant located on East Gowan Road. The received a penalty in the amount of \$2,300.

D.L. Denman Construction Company received a penalty of \$2,100 for operating without a Dust Control Permit and for failure to apply for a Various Locations Permit (VLP) at their mining site located on Highway 147.

Paragon Homes of Nevada received a penalty in the amount of \$2,000 for failing to comply with Dust Control Permit conditions and for failure to control fugitive dust generated by construction activities at its residential homes project, Black Mountain Vistas. The project is located at Paseo Verde Parkway.

Southern Highlands Development Corporation, Diamond Construction and Howell Development received a violation for allowing fugitive dust emissions to be generated from a crushing and screening plant and sand stockpiles at their master planned community project, Southern Highlands, located west of Industrial Road and north of Lake Mead Drive. The penalty was assessed was in the amount of \$2,000.

Southern Highlands Development Corporation was cited for nine separate violations for failing to comply with Corrective Action Orders, failing to abide by Dust Control Permit conditions and failure to control fugitive dust emissions at its

master planned community project called Southern Highlands, located west of Industrial Road and north of Lake Mead Drive. They received penalties totaling \$69,000.

Diamond Construction was cited for five separate violations for failing to comply with Corrective Action Orders, failing to abide by Dust Control Permit conditions and failure to control fugitive dust emissions at its master planned community project called Southern Highlands, located west of Industrial Road and north of Lake Mead Drive. They received penalties totaling \$37,000.
