

## **Public Health Update** Solid Waste Management Authority Hearing Officer Meeting -December 11, 2014

The Solid Waste Hearing Officer, under authority granted in Nevada Revised Statute (NRS) 444.629, conducts monthly hearings to settle cases involving illegal dumping and other solid waste matters. At the December 11, 2014 hearing, the following cases were adjudicated:

I. MATTERS REQUIRING HEARING OFFICER ACTION

## A. NOTICES OF VIOLATION WITH CONTESTED FACTS:

1. **Raymond Lloyd Blaine** – NOV #SW14-1049/A0- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about July 30, 2014; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located on the west side of 6150 Palmyra Avenue, Clark County, Nevada on or about July 30, 2014. *(for possible action)* 

Hearing officer found Raymond Lloyd Blaine in violation and imposed a penalty of \$900 for each of 1) and 2). Corrective action of removal and proper disposal of waste is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

2. Beck N Call, L.L.C. and Danielle Holliday – NOV #SW14-1206/R2- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about June 12, 2014; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 10420 South Rainbow Boulevard, Clark County, Nevada on or about June 12, 2014. (for possible action)

3. **Yang Li** – NOV #SW14-1147/R2- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about September 3, 2014; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 6480 Spring Mountain Road, Clark County, Nevada on or about September 3, 2014. *(for possible action)* 

Hearing officer found Yang Li in violation of 2) and imposed a penalty of \$900. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

4. **Majestic General Contractors, LLC** – NOV #SW14-1053/R2- For 1) causing or allowing sewage or accumulation of human excreta to overflow on property located at 4640 Koval Lane, Building 49, Clark County, Nevada on or about August 7, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on August 7, 2014. *(for possible action)* 

Hearing officer found Majestic General Contractors, LLC in violation of 2) and imposed a penalty of \$900. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

5. Natalie Mills – NOV #SW14-1038/K5- For 1) causing or allowing sewage or accumulation of human excreta to overflow on property located at 368 North 15<sup>th</sup> Street, Las Vegas, Clark County, Nevada on or about August 4, 2014 and August 6, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on August 4, 2014. (*for possible action*)

6. **Paramount Fund II, LLC** – NOV #SW14-1003/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about July 24, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on July 28, 2014. *(for possible action)* 

Hearing officer found Paramount Fund II, LLC in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation.

7. **Camden Operating, L.P.** – NOV #SW14-899/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about June 25, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on July 1, 2014. *(for possible action)* 

Hearing officer found Camden Operating, L.P. in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

8. **Camden Operating, L.P. –** NOV #SW14-929/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about July 2, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on July 7, 2014. *(for possible action)* 

Hearing officer found Camden Operating, L.P. in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

9. **Stephen C. Slender** – NOV #SW14-957/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about July 10, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on July 15, 2014. *(for possible action)* 

Item continued to January 8, 2015 agenda.

10. 54 B LLC – NOV #SW13-1498/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about November 19, 2013; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on November 22, 2013 with extension of the Order deadline extended to July 28, 2014. (*for possible action*)

Item continued to January 8, 2015 agenda.

11. **Brian J. Horner** – NOV #SW14-757/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about May 21, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on May 30, 2014 with extension of the Order deadline extended to August 15, 2014. (*for possible action*)

Hearing officer found Brian J. Horner in violation of 2) and imposed a penalty of \$500. Corrective action of removal and proper disposal of waste is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation. 12. **S & J Properties, LLC –** NOV #SW14-832/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about July 21, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on August 25, 2014. *(for possible action)* 

Item continued to January 8, 2015 agenda.

 4USA LLC – NOV #SW14-894/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about June 26, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on August 4, 2014. (*for possible action*)

Hearing officer found 4USA LLC in violation and imposed a penalty of \$900 for each of 1) and 2). Corrective action of removal and proper disposal of waste is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

14. **Blue Sand Holdings, LLC** – NOV #SW14-1063/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about August 11, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on August 13, 2014. *(for possible action)* 

Hearing officer found Blue Sand Holdings, LLC in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation.

15. Homes to Go LLC and Lawrence Donald Suttles, Jr. – NOV #SW14-1086/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about August 13, 2014; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on August 18, 2014. (*for possible action*)

Hearing officer found Homes to Go LLC and Lawrence Donald Suttles, Jr. in violation and imposed a penalty of \$900 for each of 1) and 2). Corrective action of removal and proper disposal of waste is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

- B. <u>NON-CONTESTED NOTICES OF VIOLATION</u>: The Hearing Officer may approve or disapprove the agreed resolution. Upon disapproval of the agreed resolution, the Hearing Officer will set a date for the hearing of any such Notice of Violations.
  - 1. **Daniel Rossal dba Eagle Hauling Services LLC.** NOV #SW14-1105/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about November 19, 2013 and July 25, 2014; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located at 3834 West Gowan Road, North Las Vegas, Clark County, Nevada on or about November 19, 2013 and July 25, 2014. *(for possible action)*

Hearing officer found Daniel Rossal dba Eagle Hauling Services LLC in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation.
