The Southern Nevada District Board of Health will conduct a PUBLIC HEARING on Thursday, October 22, 2009 at 8:30 a.m., during its regular monthly meeting in the Clemens Room at the Southern Nevada Health District (SNHD) Ravenholt Public Health Center, 625 Shadow Lane, Las Vegas, Nevada to take testimony and consider adoption of amendments to the *Southern Nevada Health District Regulations Governing the Sanitation and Safety of Body Piercing Establishments*. These proposed Regulations will be a comprehensive directive to standardize how body piercing establishments and body art special events are regulated. NOTE: In the case these Regulations are not presented at the October 22, 2009 meeting, they will be presented for PUBLIC HEARING at the Southern Nevada District Board of Health regular monthly meeting on November 19, 2009 at 8:30 a.m. in the Clemens Room at the Southern Nevada Health District Ravenholt Public Health Center.
