J. Immunization Activities:

- 1. The Pfizer Infant/children electronic, telephonic reminder recall was sent out for December.
- 2. Total flu vaccines administered from all funding sources for December was 2108.
- 3. Total flu vaccines administered to date is 8765 doses.

K. Immunization Outreach Activities:

- 1. The Child Care program conducted Tdap and Flu immunization clinics at 15 Child care centers; 234 adults and 178 children were seen and 184 Tdap and 380 flu vaccines were given.
- 2. The Outreach Immunization team conducted a clinic for adults with a Shots 4 Tots clinic at Project Homeless Connect at Cashman Center on December 6th. 173 adults received 469 vaccines.
- 3. The Outreach team gave a monthly total of 314 Tdap doses to adults who are uninsured or underinsured.

L. Shots for Tots Activities:

Shots 4 Tots Week was celebrated the week of December 17-21, 2012.

- 1. Valley View Public Health Center saw 67 children.
- 2. Henderson Public Health Center saw 26 children.

- 3. East Las Vegas Public Health Center saw 89 children.
- 4. North Las Vegas Public Health Center saw 9 children.
- 5. Mesquite Public Health Center saw 10 children
- 6. Total children clients seen in all PHC locations during Shots 4 Tots week was 201.
- 7. SNHD partnered with the 100 Black Men for their Holiday Event on December 1st, the Shots 4 Tots clinic gave 158 vaccines to 56 children.
- 8. The Shots 4 Tots clinic held during the Project Homeless Connect event at Cashman Center on December 6th gave 63 vaccines to 23 children.

M. 2012-2013 Influenza Season Activities:

- 1. A Tdap/flu vaccine clinic was conducted at Cornerstone Church Community Event on December 22. 50 clients were given 76 vaccines.
- 2. 156 adult doses of flu vaccine and 21 child flu vaccines were given at the Project Homeless Connect at Cashman Center.
- 3. 34 adult doses of flu vaccine and 41 child flu vaccines were given at the Holiday Event on December 1st.
- 4. The Outreach team gave a total of 605 flu vaccines for December.

II. Community Health Nursing Program:

A. Maternal Child Nursing Program/Child Care Health Consultation (CCHC):

The MCH team is continuing with the nursing case management of eight children with elevated blood lead levels. In December 2012, there were no children through age 72 months reported with an elevated blood lead level. All of the families, whose homes were inspected, have had lead education. One family continues to decline an environmental health evaluation. The MCH team has been tracking clients referred for developmental delays, medical issues, and suicide risks since 7/2011. In December 2012, one child was referred to a Developmental/Growth specialist. The Child Care Health Consultants provided 4 classes for various child care facilities.

B. Special Project Team and Healthy Kids Team:

The Healthy Kids staffs continue to provide Healthy Kids exams at the East Las Vegas Public Health Center and at the Valley View location. Exams performed at both locations have increased over the last month. Sports, daycare and camp physicals through the team's Kids Clinic continue to be available at the Valley View facility, and at the Henderson and East Las Vegas Public Health Centers. A new team nurse was hired in December and is scheduled to start January 7, 2013. She replaces a nurse that transferred to HIV Case Management.

C. Nurse Family Partnership (NFP):

The Nurse-Family Partnership has 107 active clients. Two additional nurse home visitors hired with the MIECHV funding will start in January 2013. The team will begin participation in the federal Maternal and Infant Home Visiting Program Evaluation (MIHOPE) in the first quarter of 2013. This study was mandated by congress as part of their funding for home visiting programs. The state of Nevada and its funded home visiting programs were selected for the evaluation. The entire team will participate in this evaluation.

Training for the federally funded Maternal Infant and Early Childhood Home Visiting program data collection for the state of Nevada is scheduled for January 14, 2013. The two new nurse home visitors funded by this program, and the Nurse Family Partnership Team Leader, Supervisor, Manager and Administrative Assistant will be involved in the training and data collection (benchmarks) required as a result of the funding.

D. Refugee Health Program:

The Refugee Health Program saw 36 new clients during December. Of the 36 clients seen, 5 referrals for treatment were required: 1 for follow up on ova and parasites and 4 for TB issues. Clients may have more than one disease.

V. <u>Tuberculosis Clinic</u>:

In December, the TB clinic conducted its last quarterly cohort review for 2012; reviewing twenty-two cases. There was no pediatric clinic for the month of December and only two adult clinics. The contractual physicians pare down services at this time of year. The weekly clinics will be up and functioning at full capacity beginning again in January.

The Nevada State TB Controller has been meeting with staff regarding plans for World TB Day in March 2013. Some of the ideas planned are to resume the statewide coloring contest; a museum exhibit on TB, a health professional's conference and a statewide training for staff on bringing awareness of TB to the community.

A new disease investigator was hired to replace the vacated position and training is in progress. We received notice that one of the Community Health Nurses will be transferring to another program within the Nursing Division so recruitment and hiring will need to take place to fill that position.

The Public Health Advisor, assigned to TB was slated to begin a temporary duty assignment in another state but that is on hold at this time. This allowed the PHA to move forward with the scheduled meeting for Corrections personnel. These meetings strengthen relationships between organizations and fulfill correctional liaison expectations.

Lastly, TB staff began participating in a sample shipping time study between SNHD and the Nevada State Public Health Lab. The purpose is to study sample shipping procedures and identify delays in delivery to improve sample integrity.

The TB team is also discussing and developing a new Board of Health report to showcase the work of the program beginning 2013.

VI. Sexual Health Clinic (SHC):

The SHC continues service at 100% of capacity. The client numbers remain consistent taking into consideration the days of service delivery due to the holidays during the month of December. The SHC will conduct trainings to increase the quality of services, improve customer service, and increase efficiency. These initiatives will be ongoing and includes all the HIV/STD surveillance staff.

The SHC successfully continued providing services for the brothel workers. During the month of December, 8 clients were seen.

Referring to the statistical report in WebIZ the number of clients provided service under the treatment "arm" of SHC for this past month was 1,165; for other clinic related services the total number of clients served at this center equaled 1,224.

VII. Nursing Quality Management:

There was no meeting of the large group. The subgroup meeting regarding chart review did not occur with Immunization due to a conflict in scheduling.

VIII. Public Health Centers (PHC):

A. East Las Vegas PHC

Lester Rossi started as an Administrative Assistant December 8th and Mary Cooper started December 24th. Both staff members are former employees of the Health Card program. One additional Spanish speaking Administrative Assistant is in recruitment as well as 1 Spanish speaking RN (See activity report for clients served).

B. Henderson PHC

A supervisor position is in the recruitment process for this location. The Senior Public Health Nurse (Nursing lead) is currently being filled by Maria Gueco in an "act as" capacity and will also go into recruitment once the supervisor is hired.

IX. Family Planning Summary:

Family Planning service numbers remain consistent with the available days for service delivery. Once again, service numbers have decreased due to the holidays.

A. Family Planning Community Outreach Activities:

The Family Planning Health Educator participated in 2 community exhibits and 3 exhibits which reached 196 teens, 13 parents and 7 providers who serve youth. Over 93 post cards were disseminated and 7 information fact sheets for service providers.

During the month the Teen Prevention Pregnancy and Family Planning programs worked to expand the community outreach capacity. It included approving policies and procedures for the new Teen Hotline, and promotional and registration materials development for Be Proud! Be Responsible! Classes are now available at the East Las Vegas Public Health Center. The new Teen Hotline will allow evaluation of the impact and response to community outreach to the teens and potentially improve customer service to teens by providing a user friendly, efficient phone number for this hard to reach population.

B. Teen Pregnancy Prevention (TPP):

1. Curricula Delivery: Total of 9 trainings were delivered; 6 in Juvenile Detention, 3 in Juvenile Probation. No cancellations.

65 Total Participants; Males, 71%; African Am. 29%; Hispanic 39%; Other/multi-racial 32%.

Incentives Distribution: 110 gift cards were distributed at the end of each training; 48 issued for completion of 3 month surveys and 38 issued for 6 month surveys for a total of 196 gift cards issued for the month of December.

2. Special Projects:

a. Completed Be Proud! Be Responsible! For 9th graders at Innovations International Charter

- School (IICS). The program was provided in one hour modules during Health class over the course of two weeks. Each participant received parental consent and received a gift bag at the conclusion of the program. Total participants 50; Females 52%, Males 48%, African-American 14%, Hispanic 60%, Other/Multiracial 26%.
- b. The Southern Nevada Community Coalition has established a governance structure and completed its strategic plan. It's first initiative is the development of parent workshops to educate parents on how to talk with teens about sexual and reproductive health. The first workshop is scheduled for January 29th, 6:00 8:30 p.m., at Walnut Cecile Community Center.
- c. TAPP youth completed a 4 hour Peer Educator training on December 27th. TAPP has applied for a \$1,000 grant through the City of Las Vegas, Youth Neighborhood Association Partnership Program (YNAPP). Their proposed project is to provide care packages that include information and referrals for sexual and reproductive health to homeless youth at the Shannon West Homeless Youth Center. TAPP has been invited to give a presentation to YNAPP about the project on January 8, 2013.
- d. TPP met its deadline for submitting a carryover budget and work plan by December 31, 2012. Approval of carryover funding is expected in March.
- e. TPP completed its report on the seven parent focus groups held in March of 2012. Reports are available on request.
- f. To achieve Year 3 work plan objectives, several new sexual and reproductive health training curricula are being developed for parents, mentors and other adults who work with youth. Agencies participating in the parent/adult training include the Department of Family Services and Big Brother Big Sisters.

X. Nursing Development/Community Outreach Educator Program

A. Education:

- 1. Cancelled one CPR classes due to lack of participants.
- 2. Two presentations were given by pharmacy students with 18 in attendance.

B. Student Activities:

- 1. Began scheduling 48 UNLV Nursing students for their 4 hours of observation experience in February.
- 2. Facilitated paperwork for 2 Pharmacy students.
- 3. Facilitated paperwork for Catholic Charities 6 hours of observation in the Refugee Clinic.

C. Other Activities:

- 1. Worked in TB Clinic 4 days a week.
- 2. Audited Venipuncture class.
