DISCUSSION:

Amendment Number 4 to the Interlocal Agreement revises the service category allocations.

FUNDING:

Amendment Number 4 revises the service category allocations and increases the funding from \$1,569,686.43 to \$1,611,585.43 which is funded by the Department of Health and Human Services through a grant with Clark County. The program areas are funded as follows:

This Amendment Number 4 to the Agreement is made and entered into this _____ day of _____, 2013, by and between Clark County, Nevada, hereinafter referred to as "COUNTY," a political subdivision of the State of Nevada, on behalf of the Clark County Department of Social Service, hereinafter referred to as "CCSS," and SOUTHERN NEVADA HEALTH DISTRICT, hereinafter referred to as "PROVIDER."

WHEREAS, COUNTY and PROVIDER entered into an Agreement on November 17, 2009, as amended on May 15, 2012, to provide outpatient/ambulatory medical care, early intervention services, medical case management, outpatient substance abuse services, and continuous quality management to clients within the Transitional Grant Area (TGA); and

WHEREAS, Section VIII, paragraph 20 authorizes the parties to amend the agreement upon mutual consent in writing; and

NOW, THEREFORE, for and in consideration of the mutual promises and conditions, which are hereinafter collectively set forth, said parties do hereby agree as follows:
