Subject: Nursing Monthly Report – February 2013

DIVISION OF NURSING DIRECTOR REPORT

I. Immunization Program

A. Immunization Activities

1. Pfizer Infant/children electronic, telephonic reminder recall February 9, 2013.
2. Hope World Wide reminder recall for children 19-35 months re-initiated.
3. Immunization clinic staff continues to promote North Las Vegas Clinic by handing out flyers to local businesses.
4. Family Leadership Initiative promoted Tdap, flu and hepatitis B vaccinations at Valley View Immunization Clinic 2/27/2013 and 2/28/2013.

B. Immunization Outreach Activities

1. On February 2nd, informational booth and flu/Tdap clinic was conducted at the National Association for the Education of Young Children (NAEYC) Educational Development Conference with 12 flu vaccines and 13 Tdap vaccines given. Information was given to 60 Child care professionals.
2. On February 23rd, a Tdap/flu clinic was conducted at Del Robison Middle School with 163 clients.
3. On February 24th, a Hepatitis B Free clinic was conducted with 60 clients.
4. The Immunization Child Care program gave 201 Tdap vaccines in 17 child care centers.
5. On February 4th, an audit was conducted on a child care center related to a possible Pertussis case. 385 records were reviewed and 93% were compliant.

C. Shots for Tots Activities

- A. Shots 4 Tots Week was celebrated on February 18-22, 2013
 1. Valley View PHC saw 95 children.
 2. Henderson PHC saw 21 children.
 3. East Las Vegas PHC saw 81 children.
 4. North Las Vegas PHC saw 14 children.
 5. Mesquite PHC saw 7 children

D. SNHD 2012-2013 Influenza Seasonal Activities

1. On February 2nd a flu clinic was conducted at Seafood City Supermarket with 77 clients receiving vaccine.
2. The Immunization Child Care program gave 369 flu vaccines in 17 child care centers.

II. Community Health Nursing Program

A. Child Care Health Consultation (CCHC)

Four classes were provided at four different facilities by the Child Care Health Consultants in February 2013.

B. Nurse Family Partnership (NFP)

Two additional nurse home visitors hired with the MIECHV funding in January, 2013, have completed the first two units of the Nurse Family Partnership training and have enrolled 15 clients. Access to the data collection system to be used for the state of Nevada's portion of the program funded by the Maternal Infant and Early Childhood Home Visiting grant has been obtained by the appropriate staff. The two new nurse home visitors funded by this program, and the Nurse Family Partnership Team Leader, Supervisor, Manager and Administrative Assistant will be involved in the data collection (benchmarks) required as a result of the funding.

III. Office of HIV/AIDS/STD- Prevention, Care, Surveillance

A. Prevention Services/Community Activities

1. February 7 was National Black/HIV AIDS Awareness Day. With the help of the SNHD Public Information Office, a media blast highlighted the impact of HIV/ AIDS in the African American population along with encouragement to know one's HIV status. Free rapid testing at SNHD Sexual Health Clinic, The Center and the Community Counseling Center was offered. Throughout the month the Office of HIV/ AIDS/STD and Sexual Health Clinic conducted targeted testing outreach activities at the following sites targeting men who have sex with men (MSM) and the male African American population.
 - a. Flex Bar
 - b. Hawk's Gym
 - c. Charlie's Bar
 - d. Richard Steele
 - e. First American Methodist Episcopal Church
 - f. Clark County Detention Center
 - g. Department of Juvenile Justice Services
2. The testing and education campaign: Project Hepatitis Las Vegas launched on February 5, 2013 at the Community Counseling Center. The Office of HIV/ AIDS/STD assists with HIV and Hepatitis testing on clients after an initial screening assessment is completed by Community Counseling Center staff. Connection to HIV care is through SNHD; Hepatitis counseling and care with Community Counseling Center and First medical of Southern Nevada. This will be an on-going program.
 - a. Conducted 37 HIV tests and identified two positives.
 - b. Connected 4 previous positive people to care.
 - c. Conducted 36 Hepatitis B and Hepatitis C Tests.

- d. Administered 34 Hepatitis vaccines.
- 3. The Office of HIV/AIDS/STD and Sexual Health Clinic delivered the following educational programs:
 - a. HIV Fundamentals Course, staff development as well as court ordered bi-monthly course.
 - b. First Time Offenders Prostitution Court Ordered Program.
 - c. Clark County School District Staff Development, HIV and STD Fundamentals.

B. Sexual Health Clinic (HIV and STD Care Services)

- A. The Sexual Health Clinic has continued with the effort to enhance the abilities and skills of professional staff. As such, in February all staff was required to attend various trainings.
 - 1. Ask- Screen- Intervene, National Network of STD/HIV Prevention Training Center: A course for clinical providers who care for HIV positive patients.
 - 2. Customer Service Training, Stephanie Glover-Director of Employee Assistance Program.
 - 3. Multiple Hepatitis Employee Education trainings and webinars.
 - 4. HIV Intensive Case Management Program began collaborating with the UMC Wellness Center in providing direct Case Management Services. The goal of this service is to identify barriers to care and improve patient outcomes, keeping in line with the National HIV/AIDS Strategy. The collaboration has had immediate positive client outcomes.

C. Surveillance

- 1. Office of HIV/AIDS/STD Surveillance in collaboration with the Ryan White and Prevention Projects undertook the "out-of-care referral" search in February. Staff reviewed reports and records of more than 3,000 HIV/AIDS cases appearing (per national standards) to be outside the care delivery system. Once all possible avenues were pursued including last known physician contact, field staff undertook personal contact. Disease Investigator/Intervention Specialists (DIIS) then attempted to physically locate the client, intervening to identify barriers to care, assist clients in removing these barriers and connecting them to care through various referrals. Preliminarily, it appears that many of these clients who appeared to be out of care were actually under the care of a HIV specialist. The laboratory tests normally conducted annually as a part of HIV maintenance went un-reported because of the range of the result. This should add support to the current request by the State Surveillance staff to change the administrative code allowing all tests reportable that are indicative of HIV infection to the local health departments. Efforts to properly conduct surveillance on community viral/infectiousness of HIV in Clark County requires the report of these tests, even if clients are in "normal" ranges.

IV. Tuberculosis Clinic

- A. Significant activities for the TB clinic for the month of February:
 - 1. The TB team involved in the Trisano workgroup had several meetings to discuss Trisano testing and begin data entry testing.
 - 2. Three patients required extensive involvement for planning and implementing care. Much of the month was spent coordinating care between multiple agencies.
 - 3. Pending authorization from IT & Administration to re-launch utilization of the State Health Division's database for the collection and reporting of surveillance information to the state as well as federal agencies.

4. Initial planning has commenced for relocation of the TB clinic services off of the Ravenholt campus. Future site is collated with SNHD clinics at 400 Shadow Professional Building.

VI. Nursing Quality Management

A. Quality Management Projects

1. Billing and reimbursement for the Nursing clinics and direct client/patient care service delivery.
2. Drafted a policy & procedure for Central Safety committee for the Dr. Bluebird policy and procedure at Valley View; pending review by director.
3. Participation in a teleconference call with the State TB controller and a local California jurisdiction in the transfer of an active communicable disease client undergoing treatment.
4. Participation in real situation exercise of Bench Book in the implementation of Isolation & Quarantine for a suspect noncompliant communicable disease client not undergoing treatment.
5. Participation in an interdisciplinary internal team regarding the continuity of care of a Hansen's client.
6. Set up and facilitated a meeting with an external vendor for future infusion therapy for active communicable disease clients undergoing treatment; pending finance and legal subsequent action.

VII. Public Health Centers (PHC)

A. East Las Vegas and Henderson PHC

VIII. Teen Pregnancy Prevention (TPP)

A. Special Projects

1. TAPP youth council was awarded \$1,000 on behalf of the City of Las Vegas Youth Neighborhood Association Partnership Program (YNAPP) to implement their Homeless Youth Care Package Project. The teens were invited to attend the City Council meeting on 2/20/13 at 9:00am for presentation of the award.
2. TPP was awarded carryover funding by OAH in the amount of \$160,960 on 2/6/2012. These funds will be used to create program sustainability beyond the end of the grant funding cycle.
3. Program Information Dissemination:
 - a. TPP staff and program evaluator submitted (2) abstracts to the Office of Adolescent Health for review and selection for a 2013 Journal of Adolescent Health (JAH) supplemental publication.
 - b. Staff presentation to the February Southern Nevada chapter meeting of the Nevada Public Health Association (NPHA) and the Southern Nevada Continuity of Care Association (SNCCA).
 - c. Staff filmed an interview on the TPP program for HDTV; to air in March.

IV. Family Planning Summary

X. Nursing Development/Community Outreach Educator Program

A. Education

1. Conducted two CPR classes with 12 attending.
2. Pharmacy students conducted 4 in-service programs with 45 attending.
3. Began working on updating the Immunization Didactic Class.

B. Student Activities

1. 42 UNLV Nursing students completed their 4 hours of observation at SNHD.
2. Facilitated paperwork for the 3 Pharmacy students.

C. Other Activities

1. Worked in TB Clinic 4 days a week.
2. Attend Bloodborne Pathogens class
