

Accreditation Activities Report-September 2016

Accreditation

The application is open. Adele has sent out requests for information and is waiting for responses so the application can be filled in. The letter of support is expected to go to the BOH Oct 13th. *Weakness*: None at this time. *Plan*: continue

Domains

Teams are meeting, all have had a minimum of 2 meetings to assign work and suggest docs. *Weakness:* Critical documents and processes do not exist. *Plan:* Create a template of outline for the document, send to the division director(s) determine a deadline for completion. For larger plans write the plan and ask the lead person to review make changes and sign. Track follow up reports.

Workforce development plan:

The plan is being finalized. Tanya is correcting language order and grammar. Requests for data will be sent to HR Friday for links to training. I will send requests to HR to ensure there are links to documents referenced in plan. Will also request HR to ensure the tracking system mentioned in the plan is being used. Weakness- The plan is still in draft format. The survey was over a year ago and the training that has occurred is unknown, but is being addressed. Plan: Action items need deadlines and accountability. Adele and Tanya will complete plan create training template.

Quality Improvement

The plan is still being tweaked the plan does not agree with the templates and actions at some points. Adele has asked the writers for clarification. The team is not balanced and all divisions are not equally represented. There is no tracking mechanism for QI projects. Adele has asked the team to change this. Weakness: tracking and plan are still being tweaked. There are currently no QI projects. Until someone misses on the PM tracking there is no process to start one. Plan: Develop a culture of QI, a suggestion is to have a just do it project with rewards. This will promote QI and WFD. Adele and Tanya will address the gaps in the plan and activities after WFD plan is complete and after input from those who went to the PM/QI conference

Performance Management-

We have received Performance Measures from Administration and Environmental Health. Community Health is completed, but working on narrowing it to 10 for PM team tracking. Adele has an appointment with Rachell October 10th to complete clinical services PM. All measures received will be tracked by the PM team. Two PM team members are being sent to a conference to learn the latest in performance management. Weakness-Measures are still being created and the first tracking needs to be completed soon. There seems to be a lack of knowledge that flows through SNHD. So documents and processes are still missing. We will need to prove that all SNHD levels and employees are engaged in PM. Plan: Encourage PM to be brought up in all meetings and discussed. Start an accreditation campaign that promotes successes of PM/ QI and the accreditation process. Work with Adele Tanya and PM/QI attendees to address gaps and move forward.

CHIP

We are working to develop a brand and inform the participants via newsletter and updates *Weakness*: None. *Plan*: Priority group emails to go out.

Access- Access & Navigation-won the 2016 public health program of the year awarded by the Nevada Public Health Association- They are planning to have a community meeting here with phone in access will send dates. Has blog on United Way website Weakness: difficult to track as there are so many changes so quickly. Plan: run faster, have mini meeting with key people and create plan and messaging for all. Workforce resources and transportation- Met with primary Care Office PCO to identify data sharing needs, data commonality. We identified underserved populations and defined data parameters. Weakness: None at this time. Plan: continue. Health Insurance- Awaiting meeting to define new enrollment strategy. Weakness: None Plan: Bring data and maps to meeting to address health equity gaps.

Chronic Disease- Members are being referred to the obesity and tobacco coalitions. Brittany will keep all engaged and updated. Brittany is working on a Chronic Disease priority gp email. We have a student who will work on updating the objective goals. *Weakness:* None at this time *Plan:* continue.

Policy and Funding- United way would like to collaborate with us on bill tracking. Meeting with the Guinn Center to link bill fact sheets through HSN website. We are using UNR's template fact sheet for health equity, etc and facts for the other 2 priorities. We are looking into creating TED talks of 5 minutes or less need to ID 3-5 initial speakers and subjects. Do not need MOU with college for this work. Meeting with UNLVs school of law to determine where we want Health Impact statements. Weakness Determine which bills are being tracked, and how to collaborate with UW on this (Dignity tracks all). We need to determine speakers and who will film the TED talks. Plan: Keep going. Ask Iser to be the first TED talk on e-cigarettes and Tyrone Thompson to speak on health disparities. Look for a minimum of 3 other speakers. Have the resources read to go and schedule a January meeting for plan a resource dispersion plan.
