



Managed fathers recycling company Waste Management, Inc. for many years until 2004 when my brother James and I decided to start our own recycling company Combs Brothers, LLC. Combs Brothers, LLC provides recycling services to hotel casinos in Southern Nevada. We currently have over 220 employees servicing 30 accounts.
