# I. CALL TO ORDER

Vice-Chair Dobyne called the Southern Nevada District Board of Health meeting to order at 8:35 a.m.

# III. RECOGNITIONS

- Dr. Fermen Leguen, Chief Medical Officer and Director of Clinical Services, introduced Maria Azzarelli, Manager, Office of Chronic Disease Prevention and Health Promotion.
- Herb Sequera, Interim Division Director, Environmental Health, was introduced to the Board.
- Adult Immunization Award from Immunize Nevada

The SNHD Immunization Program was selected as this year's Outstanding Adult Immunization Program for the Southern Nevada Silver Syringe Award. This award is given to an individual, organization, or provider who demonstrates exceptional dedication to adult immunizations, especially at-risk populations, and understands the importance of vaccinating adults. Last year the Immunization Program vaccinated almost 14,000 adults including outreach efforts with the Mobile Health Collaborative and Mexican Consulate. With the Hepatitis A outbreak in

California, the team was assigned to reach the community's homeless population to offer Hepatitis A vaccine. The team quickly developed relationships with community partners and was able to offer not only Hep A vaccine but other vaccines such as Hep B and flu.

Dr. Leguen and the Board thanked Mr. David Goldstein, Public Outreach Chair for Southern Nevada Chapter of the International Code Council (SNICC) and staff for their generous \$6,000 donation to support the 2018 Drowning Prevention Media Campaign

SNICC works hand in hand with industry and the public to increase public awareness of safety in the building environment and pool safety. One of the safety priorities of SNICC is drowning prevention. Since 2009, SNICC has provided over \$145,000 in grant funding to support various swimming programs in Southern Nevada. Last year alone, SNICC's grants helped ensure that over 450 toddlers in the valley learned to swim. SNICC also provides financial support for the Southern Nevada Child Drowning Coalition and provided \$6,000 to support the 2018 Drowning Prevention Media Campaign coordinated by the Southern Nevada Health District.

Regarding the positions of Physician Assistant and Advance Practice Registered Nurse, they have now become two-tiered positions, and the stipulations to flex into the "II" position are very arbitrary. This is concerning to Ms. Harding because with the move to Primary Care, this could be used as a mechanism to pay the Primary Care staff at a higher rate than the public health staff, as well as the fact that some of these positions are now being made bargaining unit ineligible. Ms. Harding was happy to report that conversations are now occurring behind the scenes and she is glad to have Amy in place.
