That the Southern Nevada District Board of Health *approves Agreement between the Southern Nevada Health District and Maxim Healthcare Services, Inc. dba Maxim Staffing Solutions.*

DISCUSSION:

The Health District contracts with Maxim Staffing Solutions for temporary medical staffing services to fill interim vacancies and to staff planned annual events, such as Back-to-School Vaccine Clinics, and emergencies. Pending the expiration of the contract with Maxim Staffing Solutions on February 29, 2020, the Health District issued Request for Proposals SNHD-20RFP101 Temporary Medical Staffing Services on December 6, 2019. The Health District received several responsive proposals, which are being evaluated. There is insufficient time to complete the evaluations and award and execute a new contract prior to the termination of the existing contract. Therefore, to avoid any disruption of services, the Health District requests a 90-day extension of its contract with Maxim Staffing Solutions via the attached agreement.

FEES:

Fees for Services will be at the contracted hourly rates with no fixed terms.

THIS AMENDMENT A08 IS MADE WITH REFERENCE TO Professional Services Agreement SNHD-1-SA-15-058 (P1700004) (“Agreement”), effective March 1, 2015, and as amended on January 13, 2016, October 19, 2016, February 8, 2017, February 28, 2017, August 9, 2017, March 21, 2018, and January 29, 2019, by and between the Southern Nevada Health District (“Health District”) and Maxim Healthcare Services, Inc., doing business as Maxim Staffing Solutions (“Contractor”), (individually “Party” and collectively “Parties”).

WHEREAS, the Parties mutually agree to extend the term of the Agreement.

NOW, THEREFORE, pursuant to Numbered Paragraph 22 of the Agreement, the Parties hereby agree to further amend said Agreement as follows:

- 1) Numbered Paragraph 1, Term and Termination, is hereby revised to extend the end date of the Agreement through May 30, 2020.

This Amendment A08 is effective on March 1, 2020.

Except as expressly provided in this Amendment A08, all the terms and provisions of the Agreement are and will remain in full force and effect and are hereby ratified and confirmed by the Parties.
