THIS AMENDMENT A10 IS MADE WITH REFERENCE TO Professional Services Agreement SNHD-1-SA-15-058 (P1700004) (“Agreement”), effective March 1, 2015, and as amended on January 13, 2016, October 19, 2016, February 8, 2017, February 28, 2017, August 9, 2017, March 21, 2018, January 29, 2019, February 21, 2020, and April 8, 2020, by and between the Southern Nevada Health District (“Health District”) and Maxim Healthcare Services, Inc., doing business as Maxim Staffing Solutions (“Contractor”), (individually “Party” and collectively “Parties”).

WHEREAS, the Parties mutually agree to extend the term of the Agreement.

NOW, THEREFORE, pursuant to Numbered Paragraph 22 of the Agreement, the Parties hereby agree to further amend said Agreement as follows:

- 1) Numbered Paragraph 1, Term and Termination, is hereby revised to extend the end date of the Agreement through December 30, 2020.

This Amendment A10 is effective on May 31, 2020.

Except as expressly provided in this Amendment A10, all the terms and provisions of the Agreement are and will remain in full force and effect and are hereby ratified and confirmed by the Parties.
