SUBJECT: Chief Health Officer Report

Coronavirus Disease 2019 (COVID-19)

The Southern Nevada Health District continues its collaborative efforts to provide testing resources for the community. Testing is recommended for both symptomatic and asymptomatic individuals. Testing is highly recommended for:

- People with symptoms of COVID-19.
- Anyone who has been in contact with someone who has a confirmed or possible case of COVID-19.
- Anyone who was in a setting where they were exposed to a large crowd of people who
 were not wearing face coverings or maintaining social distancing.
- Anyone planning to visit someone at high risk for COVID-19 illness, including people 65
 years of age and older people with serious medical conditions.

The Health District is currently offering testing at its Community Health Center at 280 S. Decatur Blvd., Las Vegas, NV 89107. The Health District and community partners also offer sites at locations throughout the community. These sites can be found on the Health District's COVID-19 Testing Site Calendar at www.snhd.info/covid-19-testing-sites.

On Oct. 8, 2020, the COVID-19 Mitigation and Management Taskforce adjusted the thresholds it uses to monitor Nevada counties for elevated risk of COVID-19 transmission. The three measures used to flag counties for elevated risk are the average number of tests per day, the case rate of COVID-19, and the case rate paired with the test positivity rate. If a county meets two of the three criteria, it is flagged for elevated risk. The measure requiring counties to conduct an average of at least 150 tests per day was adjusted to require an average of 100 tests per day, and the test positivity rate was increased from 7 percent to 8 percent before flagging a county for being at an elevated risk.

Based on updated directives issued by the Governor's office and new legislation passed during the special session, the Health District has developed guidance for industry that is available at www.southernnevadahealthdistrict.org/guidance-to-reopen-businesses-and-permitted-facilities/. Influenza Season

The Southern Nevada Health District's Office of Epidemiology and Disease Surveillance began its 2020-2021 influenza season surveillance activities on Sept. 27, 2020 and will continue through May 22, 2021. Surveillance reports will be distributed throughout the season and available on the Health District website at https://www.southernnevadahealthdistrict.org/news-info/statistics-surveillance-reports/influenza-surveillance/.

Encouraging everyone to get vaccinated this season is more important than ever. Getting vaccinated will help to ensure medical resources are conserved, and the health care system is not overtaxed as the response to the COVID-19 pandemic continues. The flu vaccine is recommended for everyone 6 months of age and older. It is especially important for those at higher risk of developing serious complications from the flu. Many of the people at higher risk of complications from the flu are also at higher risk of complications from COVID-19.

This includes people 65 years of age and older, people with underlying medical conditions such as heart disease, diabetes, lung disease, compromised immune systems, and Blacks and Hispanics who are already disproportionately impacted by chronic diseases. It is also important to protect people more likely to be exposed to both COVID-19 and flu, including health care workers and essential workers who interact frequently with the public. Isolation and Recovery Site

The Health District's COVID-19 Isolation and Recovery Site, formerly called the Non-Congregate Shelter, has started accepting clients. The facility is located on the south side of the Health District's main facility and provides clients with COVID-19 who do not require hospitalization a safe place to shelter.

The shelter provides patients with food, clothing and shelter for the duration of their isolation period, and they are discharged after 10 days of isolation from their symptom onset or positive result. Services include case management, 24/7 medical supervision, three meals per day, and crisis counseling and medical services. Clients must be 18 years of age or older, they must be able to perform their own ADLs, must not be dependent on skilled nursing assistance or oxygen therapy, and must go through a client intake process. Services are provided free of charge.

The facility is part of the Health District's overall response plan to help keep hospital capacity at safe levels for treatment of COVID-19 patients.

Halloween Safety

The Health District issued tips for the public to help plan for a safer and healthier Halloween. Recommendations included celebrating with members of the same household or holding virtual parties. People who are at increased risk of severe illness from COVID-19, or who live with someone who is at increased risk, were advised to avoid in-person gatherings and to consider participating in lower risk events.
