THIS AMENDMENT A12 IS MADE WITH REFERENCE TO Professional Services Agreement SNHD-1-SA-15-058 (P1700004) (“Agreement”), effective March 1, 2015, and as amended on January 13, 2016, October 19, 2016, February 8, 2017, February 28, 2017, August 9, 2017, March 21, 2018, January 29, 2019, February 21, 2020, April 8, 2020, May 29, 2020, and June 29, 2020, by and between the Southern Nevada Health District (“Health District”) and Maxim Healthcare Services, Inc., doing business as Maxim Staffing Solutions (“Contractor”), (individually “Party” and collectively “Parties”).

WHEREAS, the Parties anticipate that Contractor, as a procurement contractor, will be compensated, in part, with federal funding; and

WHEREAS, the Parties mutually desire to extend the term of the Agreement.

NOW, THEREFORE, pursuant to Section 22 of the Agreement, the Parties mutually agree to further amend the Agreement as follows:

- 1) Numbered Paragraph 1, Term and Termination, is hereby revised to extend the end date of the Agreement through June 30, 2021.

This Amendment A12 is effective on January 1, 2021.

Except as expressly provided in this Amendment A12, all the terms and provisions of the Agreement are and will remain in full force and effect and are hereby ratified and confirmed by the Parties.
