**RE:** Approval of the budget augmentation for Southern Nevada Health District for the fiscal year ending June 30, 2021.

# **PETITION #32-21**

**That the Southern Nevada District Board of Health** *approve the budget augmentation for the fiscal year ending June 30, 2021 to meet the financial requirements of NRS 354.598005.* 

## **PETITIONERS**:

## **DISCUSSION**:

The augmentation procedure as prescribed by NRS 354.598005 defines when to perform an augmentation for a fund.

When the budget was prepared March 2020 and approved in May of 2020, it was believed that SNHD General Fund Budget was appropriated to cover all anticipated cost for the FY20/21. After the FY2020 audit ended in November 2020, it was determined SNHD General Fund Budget had an increase in the ending fund balance \$2,502,009. The fund balance increase will be appropriated to cover unanticipated COVID-19 response expenses at \$810,438 and \$1,691,661 to correct FY2021 Adopted Budget cost allocation in Services and Supplies budget line by \$1,591,661 and capital outlay by \$100,000. In addition, SNHD General Fund Budget increased the appropriation for transfers out to the Grant Fund by \$9,739,314 and decreased the Services and Supplies budget line by \$9,638,858 for the cost allocation budget line because of an increase in grant funding in FY2021. As a result of the increase in year end fund balance, corrections and new appropriations to the FY2021 Adopted SNHD General Fund Budget, thereby decreasing the FY2021 appropriations from \$75,297,816 to \$73,297,816.

When the budget was prepared March 2020 and approved in May of 2020, it was believed that all funds would be committed in the 2020/21 fiscal year for SNHD Grant (Special Revenue) Fund Budget. However, after the budget process SNHD received additional grant funding related COVID-19 and other SNHD programs from federal and state government agencies. The grant funding increased anticipated grant



revenue by \$41,557,460. After the FY2020 audit ended in November 2020, it was determined SNHD Grant fund had decreased by (-\$2,867,135) in the ending fund balance. The decrease is due the Federal Emergency Management Agency not reimbursing SNHD for the Non-Congregate Shelter. Despite the FY2020 ending fund balance decrease, SNHD additional grant awards will thereby increase the FY2021 appropriations from \$27,489,181 to \$69,046,641.

In addition, when the budget was prepared March 2020 and approved in May of 2020, it was believed that all funds would be committed in the 2020/21 fiscal year for SNHD Capital Improvement Fund Budget and SNHD Bond Reserve (Building) Budget. After the FY2020 audit ended in November 2020, it was determined each fund had an increase in the ending fund balance. SNHD Capital Improvement Fund Budget FY2020 ending fund balance increased by \$97,213 because of unspent funds. Thereby increasing the FY2021 appropriations from \$3,888,163 to \$3,985,376. SNHD Bond Reserve (Building) Budget fund balance increased by \$1,554,085 because of unspent funds and expenses related to the construction and staffing of the Non-Congregate Shelter (NCS) being transferred to SNHD Grant (Special Revenue) Fund. Thereby increasing the FY2021 appropriations from \$2,104,685 to \$3,658,770.

To complete the augmentation process, the attached Resolutions to Augment #01-21 for Southern Nevada Health District (General) Fund Budget, #02-21 for Southern Nevada Health District Grant (Special Reserve) Fund Budget, #03-21 for Southern Nevada Health District Capital Improvement Fund Budget, and #04-21 for Southern Nevada Health District Bond Reserve (Building) Budget for Fiscal Year Ending June 30, 2021 must be adopted. The Resolutions will be forwarded to the Nevada Department of Taxation after the adoption of the Resolutions to Augment is done.
