SUBJECT:	District Health Officer Report

Coronavirus Disease 2019 (COVID-19)

As of September 16, a total of 2,432,316 doses of COVID-19 vaccine have been administered in Clark County. The total number of vaccinations initiated is 1,397,941; the number of vaccinations completed is 1,141,912, and the number of people fully vaccinated is 1,058,157. The Centers for Disease Control and Prevention (CDC) considers people to be fully vaccinated two weeks after their second dose in a two-dose series (Moderna or Pfizer), or two weeks after a single-dose vaccine (Johnson & Johnson). More than 74 percent of adults age 18 and older have initiated vaccination, and more than 69 percent of those eligible (people 12 and over) have initiated vaccination. Approximately 61 percent of adults age 18 and older, and approximately 56 percent of those eligible have completed vaccination. The Health District also reports information about cases of COVID-19 in people who have been fully vaccinated. As of September 16, there have been reports of 9,080 fully vaccinated individuals testing positive for COVID-19. This represents about 86 cases out of every 10,000 fully vaccinated people. The Health District is reporting a total of 137 deaths have occurred in fully vaccinated Clark County residents. This represents 1 death out of every 10,000 fully vaccinated people. By comparison, the case rate is 50 deaths per 10,000 unvaccinated people. The report is also available on the data section of the Health District's website.

On Thursday, September 9, President Biden announced his COVID-19 Action Plan. The plan outlined a national strategy that is designed to employ a science-based approach to continue to respond to the pandemic by increasing vaccination rates, keeping schools open and additional mitigation, public health and health care strategies. One of the requirements of the plan is that health care workers at Medicare and Medicaid participating hospitals and other health care settings must require vaccinations for their employees. This requirement applies to all employees of these facilities, including staff not involved in direct clinical care.

The Health District is currently offering third doses of the vaccine to immunocompromised people in accordance with Centers for Disease Control and Prevention guidance. Third doses of Pfizer or Moderna are available to individuals with moderated to severely compromised immune systems and can be administered at least 28 days after second doses have been received. Patients are advised to talk to their health care providers about their medical

condition about whether getting an additional dose is appropriate for them. At this time, there is no recommendation for additional doses for people who received the Johnson & Johnson vaccine.

The U.S. Department of Health and Human Services announced a plan to begin offering COVID-19 vaccine booster shots by September 20. The FDA will need to authorize the vaccine booster shots, and the CDC's Advisory Committee on Immunization Practices will make the final recommendations on the use of boosters for the public. The Health District will follow the guidance issued by the CDC for administering booster shots to the public.

At this time, the Health District's focus continues to be on administering first and second doses of the COVID-19 vaccine to the public.

West Nile Virus

On September 2, the Health District reported that mosquitoes trapped by its Mosquito Surveillance Program in the 89014 ZIP code tested positive for West Nile virus, the first this season in Clark County. The presence of West Nile virus-positive mosquitoes serves as a reminder that people need to protect themselves from mosquito bites when they are outdoors. Since that time, additional West Nile virus-positive mosquitoes have been detected in the 89052 ZIP code.

Each year, the Health District urges people to "Fight the Bite" by taking these simple steps:

Eliminate standing water. Tip and toss water that may accumulate in items around the home, including in planters, buckets, tires, and anywhere water may collect. Maintain swimming pools and check yards for areas of sprinkler run-off. Even a small amount of standing water can support mosquito breeding.

Prevent mosquito bites. Use an Environmental Protection Agency (EPA)-registered insect repellent containing DEET, Picaridin, IR3535, Oil of lemon eucalyptus (OLE), or 2-undecanone. Wear pants and long-sleeved shirts to reduce mosquito exposure when outdoors.

Report mosquito activity. Call the Health District's Mosquito Surveillance Program at (702) 759-1633 to make a report. To report a green pool, people should contact their local code enforcement agency. More resources and contact information are available on the Health District's <u>website</u>.

Mosquito activity has been mild in Southern Nevada this season, and last year only one case of West Nile virus was reported in a Clark County resident. However, it is important to remember that West Nile virus and other diseases transmitted by mosquitoes can be serious and sometimes fatal. In 2019, the Health District reported 34 neuroinvasive West Nile cases, including two deaths, and nine non-neuroinvasive cases.

West Nile virus is commonly transmitted to people from the bite of an infected mosquito. Most people (eight out of 10) will not develop any symptoms. Some people (about one in five) will develop less severe illness. Their symptoms can include a fever, body aches, nausea, vomiting, and skin rash. Serious and every life-threatening illness can occur in some individuals. About one in 150 people infected with West Nile virus develop the more severe, neuroinvasive form of the illness. The Health District's Mosquito Surveillance Program staff sets traps throughout Clark County from April through October each year and submits specimens to the Southern Nevada Public Health Laboratory for analysis.

Flu Clinics

The Health District began offering flu vaccine at its public health centers on Tuesday, September 14. While the 2020-21 flu season was mild, likely due to COVID-19 mitigation measures such as mask-wearing, more people working and going to school from home, and social distancing, it is possible the 2021-2022 influenza season could be more active since many of these activities have decreased as businesses and schools have reopened.

During the 2020-2021 season, as of May 15, 2021, the Health District received reports of 50 influenza-associated hospitalizations and six deaths associated with flu. During the 2019-2020 season, as of May 16, 2020, the Health District had received reports of 1,398 influenza-associated hospitalizations and 54 deaths.

The flu vaccine is available to walk-in clients at the Health District's 280 S. Decatur Blvd. immunization clinic, but appointments are required at its other public health centers. Appointments can be made by calling (702) 759-0850.

The Centers for Disease Control and Prevention (CDC) estimated that flu vaccine prevented an estimated 7.5 million illnesses and 6,300 deaths during the 2019-2020 flu season.
