Executive Summary

In summary, all the departments continue to see an increase in activity and outreach. The Office of Communications issued 10 News Releases and responded to several media requests for interviews with staff. The Finance Department noted that 14 grants expired, and 6 grants were awarded. As of October 1, 2021, the Health District had 727 active employees, with a total number of vacancies of 52.4 FTEs and a total number of positions in recruitment of 90 FTEs. The Human Resources Department successfully completed 12 new hires and 138 interviews. The Organizational Development Department is currently developing a leadership training program for Health District Supervisors, Managers and Directors, starting with an off-site leadership development session to examine opportunities, and recent accomplishments. Many departments at the Health District are contributing to the finalization of the Public Health Accreditation Board (PHAB) materials to submit for accreditation in January 2022.


