**Subject:** Mike O'Callaghan Military Medical Center provisional authorization to operate as a Level

III Trauma Center within the Southern Nevada Trauma System.

#### I. BACKGROUND:

The Mike O'Callaghan Military Medical Center (MOMMC) is a general hospital operated by the United States Government and is deemed to operate in the State of Nevada per NRS 449.0301.

MOMMC has received congressional authorization to develop and maintain community partnerships and civilian patient care as an initiative to remain ready to provide contingency medical/surgical care at a moment's notice. The Sustained Medical and Readiness Trained Program (SMART) provides clinical/combat trauma currency sustainment not available at military training facilities.

As part of its initiative, MOMMC has systematically developed and reinforced community partnerships in preparation to participate in the Southern Nevada Trauma System. This has included participation in the local healthcare system, engagement with local EMS providers, and the American College of Surgeons Committee on Trauma (ACS-COT) consultative visit.

#### II. RECOMMENDATION:

The NV Division of Public and Behavioral Health (DPBH) has approved the initial application of MOMMC to be designated as a Center for the Treatment of Trauma. This eligibility is based on being a federally operated hospital and findings from comprehensive needs performed by the Division. The DPBH has directed that MOMMC must seek and obtain approval from the Southern Nevada Health District Board of Health to function as a Level III Trauma Center within the Southern Nevada Trauma System.

The OEMSTS has received and reviewed MOMMC's application. It finds its commitment and capacity to the treatment of trauma in good standing. As part of NRS 450B.237, OEMSTS has prepared an Impact Report to indicate the effect of adding a new Level III Trauma System to the existing trauma system. Based on these findings and DPBH's approval, OEMSTS and the Regional Trauma Advisory Board (RTAB, Oct 2021) recommends MOMMC be included in the Southern Nevada Trauma System as a Level III Trauma Center.

#### III. <u>CONDITIONS</u>:

If approved, staff recommends the following conditions:

- 1. ACS-COT verification and subsequent renewals of verification.
- 2. Participation in the Southern Nevada Trauma System as designed by the Southern Nevada Trauma System Plan.

The report is intended to consider provisional authorization for Mike O'Callaghan Military Medical Center as a new Level III Trauma Center.






#### **Clark County ZIP Code Map**

RE: Approval of Mike O'Callaghan Military Medical Center as a Center for the Treatment of Trauma

Dear Mr. Hammond:

The Southern Nevada Health District has provided the Nevada Department of Health and Human Services, Division of Public and Behavioral Health ("Division") with a copy of the Application for the Initial Authorization as a Center for the Treatment of Trauma from the Mike O'Callaghan Military Medical Center (MOMMC), requesting initial approval to be designated as Level III Trauma Center. Upon review of the Application, and in light of a comprehensive needs assessment performed for Clark County, Nevada, the Division of Public and Behavior Health approves the initial application by MOMMC.

#### **Statutory Authority:**

Pursuant to NRS 450B.236, "a person shall not operate a center for the treatment of trauma without first applying for and obtaining the written approval of the Administrator of the Division."

#### Further, NRS 450B.237(2) provides:

The Administrator of the Division shall not approve a proposal to designate a hospital as a center for the treatment of trauma unless:

- (a) The hospital meets the standards established pursuant to this subsection; and
- (b) The Administrator determines, after conducting a comprehensive assessment of needs, that the proposed center for the treatment of trauma will operate in an area that is experiencing a shortage of trauma care. Such an assessment of needs must include, without limitation, consideration of:
  - (1) The impact of the proposed center for the treatment of trauma on the capacity of existing hospitals to provide for the treatment of trauma;
  - (2) The number and locations of cases of trauma that have occurred during the previous 5 calendar years in the county in which the proposed center for the treatment of trauma will be located and the level of treatment that was required for those cases;
  - (3) Any identified need for an additional center for the treatment of trauma in the county in which the proposed center for the treatment of trauma will be located; and

(4) Any additional criteria recommended by the American College of Surgeons or its successor organization, other than criteria related to community support for the proposed trauma center.

If the hospital is located in a county whose population is 700,000 or more, the hospital must also receive approval from the district board of health of the county in which the hospital is located. NRS 450B.237(5).

#### **Facts Supporting Approval**

MOMMC has applied for initial approval by the State as a Level III Trauma Center. As a federally operated hospital<sup>1</sup>, and in light of the findings from the comprehensive needs assessment, the Division has determined that MOMMC is eligible for designation as a Level III Trauma Center, subject to approval by the Southern Nevada Health District.

The Division completed a comprehensive needs assessment which included substantial data on trauma coverage and shortages in Clark County. The Division has concluded that MOMMC is in the most severe professional shortage area in the area. We do not anticipate that MOMMC trauma designation is going to have a detrimental impact on the ability of other providers to provide trauma services based on location of this facility and the unique military work force. Further, allowing MOMMC to accept trauma patients is likely to maximize trauma capabilities of military professionals in the area, thereby benefiting the community as a whole.

The Division hereby approves the initial application of MOMMC to be designated as Center for the Treatment of Trauma. MOMMC must seek and obtain approval from the Southern Nevada Health District in order to be designated as a Level III Trauma Center.

Proposed geographic area to be served, including consideration of distance from existing trauma centers already serving the geographic area and the potential impact on the trauma system:

The area surrounding Nellis AFB is a developing industrial area with a relatively high crime rate that, with traffic, is 20-30 minutes or more away from the nearest trauma centers. High-risk activities on base as well as the nearby Las Vegas Motor Speedway, which hosts events as large as 80,000 people, add to the need for local trauma capability. By providing Level III trauma care at Nellis AFB, we will significantly decrease transport time to definitive care for the vast majority of cases in northeast Las Vegas and preserve capacity for more critical cases that would continue being served by the existing Level I/II trauma centers. This designation would also significantly decrease the time that Emergency Response Services are unavailable due to round trip transport times to the current Trauma Centers. As this area continues developing, the need for local trauma capability will be increasingly critical.

#### Briefly describe the hospital's capacity to provide trauma services in the community:

Mike O'Callaghan Military Medical Center (MOMMC) is a 50-bed inpatient facility which boasts a full complement of primary and specialty care, General Surgery, Orthopedic Surgery, Trauma Surgery, Emergency Medicine, five Operating Rooms (OR), two hybrid OR suites, Intensive Care Unit (ICU), a Multi-Service Inpatient Unit (MSU); all of which are required for Level III trauma care. In addition, we have multiple surgical sub-specialties, such as hand and spine surgery, as well as 24/7 on-call IR, which will allow us to provide a broader spectrum of injury care than the average Level III center. While we have traditionally cared primarily for military members, retirees and their families, our new alignment under the Defense Health Agency (DHA) has expanded opportunities for military treatment facilities to see civilian patients that enhance our wartime readiness. The addition of trauma services will be mutually beneficial to our Active Duty staff as it further expands their wartime skills and currency for deployments. Nellis AFB has already gained Congressional authorization to treat non-DoD patients and the Air Force is making significant monetary and personnel investments in MOMMC to expand the capacity and redundancy of required medical services which were previously resource-constrained due to a lack of demand by our traditional military beneficiaries. As such, MOMMC will undoubtedly meet all ACS requirements and ensure seamless base access for EMS transported trauma and critical care patients.

Briefly describe the hospital's longitudinal commitment (expected to be greater than five years) to provide trauma services in the community:

The MOMMC, Air Force Medical Service, and DHA are committed to providing trauma services to the community surrounding Nellis AFB. This is easily demonstrated in the \$150m facility expansion project that is ongoing, which will ultimately make us a 108 bed facility. This is a long-term commitment in infrastructure and personnel to include minimum staffing levels even with a high-deployment rate of military providers. In case of mass deployment situations, contract and civilian personnel will be available to ensure continuity of Trauma services. We are committed to the conditions of this designation and will participate in all local, regional, and national Trauma Quality Improvement Program and Registries as required by Nevada, ACS and the Department of Defense. Furthermore, as trauma medicine and integration of trauma systems is part of our Air Force core competencies developed over many years of wartime trauma system experience, Nellis AFB is fully committed to partnering with Southern Nevada in all Trauma System education and enhancement efforts.

#### Additional information the applicant would like to provide in support of their request:

This application represents a true win-win opportunity to bolster the Southern Nevada Trauma System and enhance our national defense. Due to our long standing relationship with the greater Las Vegas community as well as the transparent, low cost structure of military medical services, Nellis AFB is the most opportune location in the United States to build upon our strong partnership and integration with local medical entities and emergency response agencies for the greater good. Efforts such as this set a new standard for military and civilian partnerships as indicated by the 2017 National Defense Authorization Act and subsequent Congressional and DoD directives which support DoD-civilian partnerships to maximize medical deployment readiness in ways that serve our civilian partners.



The following are conditions of authorization as a center for the treatment of trauma in Clark County. By signing the application, the administrators of the hospital and the medical director of the center for the treatment of trauma acknowledge these conditions and agree to:

- Comply with the requirements of the graduated process for authorization and designation as a center for the treatment of trauma as defined in the Clark County Trauma System Regulations Section 300.000, subsections IV-VI;
- 2. Submit trauma data to SNHD and the State Trauma Registry;
- Actively participate in the Regional Trauma Advisory Board and Trauma System Performance Improvement activities;
- Provide standard financial information to assist in the assessment of the financial stability of the trauma system; and
- 5. Comply with all applicable SNHD regulations and State Health Division requirements for authorized and designated centers for the treatment of trauma.

I have read and completed the application to the best of my ability and attest to the fact the information provided is true and complete to the best of my knowledge.

I authorize the release of such information as may pertain to the purpose of this application.
