Body Art

EMPLOYMENT VERIFICATION**

Applicants must provide the Employment Verification form with the Employment Information section completed and signed by the owner or manager of a permitted facility in Clark County.

EXPERIENCE VERIFICATION**

Operators must provide the Experience Verification form with a minimum of 6 months of experience in order to receive a temporary card. If the operator was self-employed, a copy of their business license will be accepted provided their name is also listed on the business license. Body Art licenses issued by other states are subject to approval.

Apprentices must submit the Experience Verification form once the apprenticeship is completed. (Apprenticeship begins on the date you pass the written exam & must be a minimum of 6 months or longer from this date).

CARD FEES

Applicants will pay the fee on the date of application. Operators who have provided required letters will receive a 30 day temporary. Apprentices will receive a temporary card once the written exam is passed.

WRITTEN EXAM**

All applicants must take and pass a written exam. The exam questions are taken from the Tattoo and Body Piercing regulations (all applicants should study both) and available disease flyers. The exam is 100 multiple choice questions with a passing score of 80% or better. The exam is by appointment only. BLOODBORNE PATHOGENS CERTIFICATION

All operators/apprentices are required to take an OSHA compliant Bloodborne Pathogens Training (BPT) within 30 days of passing the written exam and then renew every two years. Contact Red Cross directly:

REMINDER: The Regulations require that at least one (1) person is trained in CPR and First Aid, as evidenced by current certification, and is available at the establishment during hours of operation (Section 6.2.3.4). ***Also, please be advised that it is the responsibility of the shop owner/manager to ensure that all Operators and Apprentices stay current with their training and body art card.***
