

Subject: Influenza Report for Week 51 (Dec. 19-25, 2004)

Ninety-six cases of influenza-like illness (ILI) were reported during week 51. **Criteria for inclusion as a case of ILI are fever $\geq 100^{\circ}\text{F}$ (37.8°C) and cough or sore throat.** The proportion of patient visits to sentinel providers for ILI was **2.33%** (weighted average); this remains below the national baseline of 2.5%. During week 51, the proportion of mortality due to pneumonia and influenza (P&I) in Clark County was **9.29%** and the national P&I mortality was 7.0%. The proportion of ILI cases by week in Clark County for weeks 40-51 of the 2004-2005 surveillance season reported by sentinel site surveillance is presented in the following figure:



An additional health district surveillance system monitors the number of patients visiting area medical facilities on a daily basis. Through syndromic surveillance an increase in ILI was identified in the community for the first time this season. Two new laboratory-confirmed cases of influenza have been reported to the Office of Epidemiology (OOE) during week 52. A total of six confirmed cases of influenza have been reported to the OOE this season in Clark County. Two of the six were culture-confirmed from throat swabs. Both isolates were subtyped as A (H3N2) by the Nevada State Public Health Laboratory. Three cases were confirmed by a type of rapid test which differentiates between influenza type A and B and each resulted in influenza B. The most recent case was confirmed by a type of rapid test which does not differentiate between influenza type A and B. **The Nevada law (NAC 441A) requires that healthcare providers report all positive influenza tests (including rapid tests) to the local health authority.** Physicians and healthcare workers are reminded that any unusual occurrence or suspected outbreak should be reported to the Office of Epidemiology. The 24-hour number for reporting is 759-1300.

Influenza vaccine remains available for pediatrics and high-risk adults at the Ravenholt Public Center at 625 Shadow Lane. The immunization clinics are open weekdays from 8:00 a.m. to 4:30 p.m. **Please note: the health district will be closed Friday, December 31 in observance of New Year's Day.** For more information on health district flu vaccine availability, the general public may call the district's flu information line at (702) 385-INFO (4636).
