

Southern Nevada Weekly Influenza Surveillance Snapshot CDC Week 48, Nov 25, 2018 to Dec 1, 2018

Summary:

Influenza surveillance for Clark County, Nevada includes data collected from local acute care hospitals and other healthcare providers. During week 48, influenza activity increased slightly locally and nationally. In the state of Nevada, the geographic spread of influenza was regional, and the ILI activity level was minimal. In Clark County, as of 12/1/2018, thirty-two influenza-associated hospitalizations and zero influenza-associated deaths were reported. The proportion of emergency room (ER) and urgent care clinic visits for Influenza-Like Illness (ILI) was 2.8% in week 48 which was lower then the proportion in week 47 (2.9%). Approximately 52% of area ER and urgent care clinic visits for ILI were children under 18 years of age. Southern Nevada Health District will continue to update the public on the progression of the season and encourage influenza vaccination for all persons 6 months of age and older.

Figure 1: Percent of Clark County Deaths Registered with Pneumonia and/or Influenza by Week



Figure 2: Distribution of Confirmed Cases* by Virus Strain, Clark County, NV




Figure 3: Weekly Proportion of Emergency Room and Urgent Care Clinic Visits for Influenza-Like Illness, Clark County, NV




Figure 4: Age Distribution of Emergency Room and Urgent Care Clinic Visits for Influenza-Like Illness, Clark County, NV




Figure 5: Seasonal Trends of Confirmed Cases of Influenza, Clark County, NV




Figure 6: National ILI Activity Level- 2018-2019 Influenza Season CDC Week 48 ending Dec 1, 2018
