

Southern Nevada Weekly Influenza Surveillance Snapshot CDC Week 43, October 23, 2022 to October 29, 2022

Summary:

Influenza surveillance for Clark County, Nevada includes data collected from local acute care hospitals and other healthcare providers. In Clark County, as of 10/29/2022, for the 2022 - 2023 influenza season, 10 influenza-associated hospitalizations and zero deaths associated with influenza were reported. The percentage of emergency room (ER) and urgent care clinic visits for influenza-like illness [ILI(fever plus cough or sore throat)] slightly increased from 4% in week 42 to 4.4% in week 43. Approximately 36% area ER and urgent care clinic visits for ILI were made by children 0 - 4 years of age which was higher than week 42 (32%). Influenza A has been the dominant type circulating. Nationwide, during week 43, early increases in seasonal influenza activity continued. The southeastern and south-central areas of the country are reporting the highest levels of activity followed by the Mid-Atlantic and the south-central West Coast regions. Four point three percent of patient visits reported through the U.S. Outpatient Influenza-like Illness Surveillance Network (ILINet) were due to respiratory illness that included ILI. This percentage was above the national baseline of 2.5%. Among 55 states/jurisdictions, the respiratory illness activity level in the state of Nevada increased from Minimal to Low. Southern Nevada Health District will continue to update the public on the progression of the influenza season and encourage influenza vaccination for all persons 6 months of age and older without contraindications.

Figure 1: Percent of Clark County Deaths Registered with Pneumonia and/or Influenza (P&I) by Week





Figure 2: Distribution of Confirmed Cases* by Virus Strain, Clark County, NV

Figure 3: Weekly Proportion of Emergency Room and Urgent Care Clinic Visits for Influenza-Like Illness, Clark County, NV




Figure 4: Age Distribution of Emergency Room and Urgent Care Clinic Visits for Influenza-Like Illness, Clark County, NV




Figure 5: Seasonal Trends of Confirmed Cases of Influenza, Clark County, NV




Figure 6: National Outpatient Respiratory Illness Activity Level- 2022-2023 Influenza Season CDC Week 43 ending October 29, 2022



*Confirmed Cases= Laboratory confirmed by PCR, culture, immnofluorescent antibody staining (direct or indirect), IHC antigen staining, rapid influenza diagnostic tests (RIDTs) with hospitalizations for 24 hours or longer, or with deaths. This weekly report is only a reflection of the hospitalized cases and deaths reported for the current influenza season (Table 1 and Table 2). Number of total confirmed cases in Figure 5 includes number of hospitalization, deaths with hospitalization and deaths without hospitalization.

Note: The total number of confirmed cases presented in this report is subject to changes due to possible delays in reporting and processing.
