General Update

During the week ending December 03, 2011, the following viruses were identified through PEWSS with a high volume of testing (Fig. 1): Adenovirus, Parainfluenza 1 and RSV.

Over the past five weeks (Tables 1 & 2), the following were identified in the community through PEWSS: Parainfluenza 1 has been circulating at high levels.

Adenovirus has been circulating at low levels.

Human Metapneumovirus, Parainfluenza 2, Parainfluenza 3 and RSV have been sporadically identified. Influenza A and Influenza B have not been identified.


