

A GUIDE TO THE CERTIFICATION PROCESS FOR INDIVIDUAL SEWAGE DISPOSAL SYSTEMS (ISDS) AND/OR WATER SUPPLY WELLS

Inspection appointments cannot be made until the application is returned and payment is verified. Payment can be made in one of the following ways:

- In Person at the Southern Nevada Health District (SNHD) office located at 280 S Decatur Blvd. Counter hours are from 8AM 3:30PM, Monday through Friday, and the counter is closed for lunch between 12:30am-1:30pm. <u>Please schedule an appointment before coming in to ensure that staff is available for processing.</u> Acceptable methods of payment include company checks, cashier's checks, money orders, and cash. Visa and MasterCard are only accepted if your government ID matches EXACTLY what is on the card. **Personal checks are not accepted.**
- The application can be returned by email. The invoice will be forwarded and payment can be made online at http://snhd.info/eh/payment. All major credit cards are accepted. Payments made online can be verified after 12 PM the following day or the payment confirmation can be forwarded to SNHD staff.

In the event that a loan is cancelled or an inspection is not approved, fees are **NON-REFUNDABLE.**

ISDS Certification Preparation Requirements: The two-foot settlement compartment lid to the septic tank itself must be **removed** for the inspection. Unless there is a riser or manhole cover, excavation of the lid is necessary in order to remove the lid. The inspector will need to examine the inside of the septic tank as well as determining if the septic tank will need to be pumped. <u>Please note that our inspector is not responsible for opening the lid for the inspection.</u> It should be opened prior to his visit. If the lid is not open at the time of inspection, then a \$275.00 reinspection charge will assessed for any additional site visit.

Well Certification Preparation Requirements: If your inspection includes a private or community well certification, you will be required to order a water analysis (Domestic Water Analysis Panel) completed by a Nevada Certified Drinking Water Laboratory. This water analysis is separate from the inspector's site visit. We will require the original **CERTIFIED** results which typically have a <u>raised seal</u> on them to verify that the report is an original. The cost of water analysis is **NOT** included in the certification fees, the requestor can inquiry with any certified laboratory as to the cost of the water analysis. A copy of the well driller's log is required for completion of the certification. If a copy is not already on file with SNHD, then you must supply us with a copy. If you do not have a copy, one can be obtained from: http://water.nv.gov/welllogquery.aspx

**Wells must be in good standing with the Nevada State Division of Water Resources to receive certification.

Access: Nobody is required to be present at the inspection but the inspector must have access to the property for septic and/or well, whether community or private. Coordinate and arrange this in advance so these areas are not locked. If any animals are present, the inspector will not attempt entry either. If our inspector does not have access, then a reinspection fee of \$275.00 will be charged. Please provide a contact name and phone number in the event the inspector has any questions.

<u>Release of Certification</u>: The certification will be released for pickup or emailed once all required documentation is received and SNHD has proof that any issues notated at the inspection have been resolved. Once all the necessary paperwork has been provided, the certification is usually completed within 24 hours.

If the inspector is NOT able to access the ISDS and /or well head on the scheduled inspection date, a reinspection fee of \$275 will be assessed for another site visit. Any compliance issues found as a result of the loan certification will need to be addressed by the current or future owner and 5. failure to address the issues may result in referral to ISDS Plan Review for further action. 6.
