Say "No" to SPAM (but not **really** the spiced ham variety)

Several MRC volunteers have indicated that e-mails sent from health district staff are winding up in their "Spam" or "Junk E-mail" folders. (Perhaps this could be the reason we haven't heard from many of you for a while!)

Staff have learned that many anti-virus software programs (i.e., Norton) protect their users by kicking out e-mail messages that are delivered as part of a large distribution list. With 315 volunteers on our roster, this may be the cause of misdirected e-mails.



If you find emails from the health district in your "Spam" or "Junk E-mail" folder, add the following e-mail addresses to your contact list: martel@snhdmail.org and moran@snhdmail.org. Additionally, contact staff if you are encountering this problem so they can determine how widespread it is. Staff are reducing the size of distribution lists, which may help.

Veterinary preparedness workshop trains vet staff


In September, 40 veterinarians and veterinary technicians participated in a workshop and exercise specific to disaster preparedness and response at the Oquendo Center for Clinical Education.

The morning workshop included lectures on personal, family, practice and community preparedness, the Incident Command System and how to set-up temporary animal shelters.

The afternoon exercise was developed using an earthquake scenario. As a result, 20 dogs delivered by Clark County Animal Control

from the Lied Animal Shelter were decontaminated, examined, micro-chipped and placed in a temporary shelter set-up by exercise participants. Licensed veterinary professionals received eight education credits from the Nevada State Board of Veterinary Medical Examiners for participating in the workshop and exercise.

This event will be repeated in September, 2010.

Tax Credits: Another perk to MRC involvement

Volunteers in the United States may receive tax deductions from the federal government on many costs associated with volunteering, such as mileage and other travel expenses, parking, uniforms, etc. These deductions apply only if you are not getting reimbursed for these expenses, and you are itemizing on your tax form (not using the 1040EZ form).

When volunteers drive their own vehicles to carry out volunteer duties, including to and from trips to their volunteer service, the IRS permits a deduction of 14 cents per mile. MRC volunteers who want a tax deduction should keep good records of mileage in performing volunteer duties, and ask their tax preparation specialist for information on deducting volunteer expenses.
