- > The Committee may remove an item from the agenda or delay discussion relating to an item on the agenda at any time.

If any member of the Committee wishes to extend the length of a presentation, this may be done by the Chairman or the Committee by majority vote.
- **II.** <u>CONSENT AGENDA</u>: Items to be considered by the Drug/Device/Protocol Committee which may be enacted by one motion. Any item may be discussed separately per Committee Member request before action. Any exceptions to the Consent Agenda must be stated prior to approval.
