The above-entitled matter came in for a duly noticed public hearing on August 22, 2018. On August 10, 2018, the Southern Nevada Health District suspended Thai Pepper's permit pending revocation, in accordance with Nevada Revised Statute 446.880 and Southern Nevada Health District Regulations Governing the Sanitation of Food Establishments, Chapter 8-306, due to ongoing noncompliance with basic food safety as well as Health District regulations. Pursuant to the Regulations, Thai Pepper timely requested a hearing on the suspension pending revocation. On August 22, 2018, properly noticed Thai Pepper appeared before the Hearing Officer.

Thai Pepper agrees to the violations as alleged. However, the Hearing Officer agrees to the provisions the parties agreed upon to settle this matter. Based thereon and good cause appearing;

IT IS HEREBY ORDERED that the permits PR0018995 to operate Thai Pepper are lifted from suspension with the following conditions:

- 1. Facility will have a Certified Food Protection Manager onsite at all operating times.
- 2. Facility will have visits from a Food Safety Consultant one day a week for the next eighteen (18) months.
- 3. Food Safety Consultant contract will notate that the Food Safety Consultant has the ability to hire and fire any employees.
- 4. All logs, including but not limited to opening checklist, cooling, and refrigeration must be kept onsite and be available for inspection for the next eighteen (18) months.

5. Facility will not use time as a control for PHF/TCS foods; all PHF/TCS foods must be

maintained at 41°F or below, or 135° or above.

6. Facility will have unannounced quarterly inspections for the next eighteen (18) months. All

inspections must pass with an A grade, ≤ 10 demerits. No imminent health hazards can be

identified during active operations. No repeat critical or major violations on consecutive

inspections will be allowed.

7. Facility staff will schedule a reinspection prior to reopening. The reinspection must pass

with an A grade.

8. Facility will have monthly pest control visits from a licensed Pest Control Operator for the

next eighteen (18) months, more as necessary if activity is found.

9. Facility will be professionally deep cleaned once a month for the next eighteen (18) months.

10. Facility will pay all applicable fees.

11. If any of the above referenced conditions are violated within the next eighteen (18) months,

the permits will be immediately revoked without administrative appeal rights. Thai Pepper is

waiving its right to a hearing on this matter.

12. If revoked, Ausvin Chukitkul and any current officers may at no time own, operate, or work

in a food establishment at this building/location.
