#### III. MATTERS REQUIRING HEARING OFFICER ACTION:

Pad Thai (PR0005492), 860 S. Rancho Dr. #2: Proposed Revocation of Permits

## **Opening Statements:**

Heather Anderson-Fintak announced that the hearing is being recorded. Ms. Anderson-Fintak states a settlement agreement has been reached between SNHD and the owner of Pad Thai which will allow the facility to open and operate again with the following stipulations:

- Facility will have visits from a Food Safety Consultant two (2) days per week for the next eighteen (18) months. Documentation must be kept on-site for each visit.
- Food Safety Consultant Contract will notate that the Food Safety Consultant has the ability to hire and fire any employees.
- Facility will be required to implement an opening checklist and refrigeration logs daily. These are required to be kept onsite and available for review by SNHD.
- Facility will be required to schedule a reinspection prior to opening. The reinspection must pass with an "A" grade. Pay all applicable fees.

- Facility will be deep cleaned by a professional cleaning company once per month for the next eighteen (18) months. Documentation for this must be kept on-site at all times.
- If the business is sold, any current officers of Thai Dee Restaurant/Pad Thai/Bangk or Tepalai, LLC may, at no time own, operate, work, or be associated in a food establishment at this building/ location.
- The wok line is to be completely replaced within the next six (6) months (by October 3, 2019). You must apply for a remodel no later than September 3, 2019 at SNHD's Facilities Design Assessment & Permitting (FDAP) office at (702) 759-1258.
- If any refrigeration unit is unable to hold food at 41 degrees F and below, the entire unit will be replaced, not repaired.
- A Person in Charge (PIC) with a Certified Food Protection Manager (CFPM) certification must be on duty during all hours of operation. This document must be kept on-site and available for review by SNHD.
- Facility will have unannounced inspections for the next eighteen (18) months. All inspections
  must pass with and "A" grade of 10 demerits or less with no repeat major or critical violations
  on consecutive inspections. No Imminent Health Hazards can be identified during active
  operations.

Hearing Officer Melton asked Tewan Parnishsuko, owner of Pad Thai, if he understands and accepts the conditions set forth in the Settlement Agreement. Mr. Parnishsuko states understands and accepts the conditions.
