



**Public Health Update**  
**Solid Waste Management Authority Hearing Officer Meeting – August 13, 2015**

The Solid Waste Hearing Officer, under authority granted in Nevada Revised Statute (NRS) 444.629, conducts monthly hearings to settle cases involving illegal dumping and other solid waste matters. At the August 13, 2015 hearing, the following cases were adjudicated:

I. MATTERS REQUIRING HEARING OFFICER ACTION

A. NOTICES OF VIOLATION WITH CONTESTED FACTS:

1. **Cody James Schumacher** – NOV #SW15-534/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about May 8, 2015; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located north of 8601 Helena Avenue, Clark County, Nevada on or about May 8, 2015. (*for possible action*)

Hearing officer found Cody James Schumacher in violation of 2) and imposed a penalty of \$900. Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation.

2. **Miguel A. Uriostegui and Rosa V. Donis** – NOV #SW15-601/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about May 22, 2015; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located at the southeast corner of Helena Avenue and North Jensen Street, Clark County, Nevada on or about May 22, 2015. (*for possible action*)

Hearing officer found Miguel A. Uriostegui and Rosa V. Donis in violation of 2) and imposed a penalty of \$500. Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation.

3. **Michael Tagliaferri** – NOV #SW15-508/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about April 29, 2015; and 2) placing, depositing or dumping or causing to be placed,

deposited or dumped dirt upon the vacant parcel located east of 6280 North Hualapai Way, Clark County, Nevada on or about April 29, 2015. *(for possible action)*

Item continued to September 10, 2015 agenda.

4. **Herbs and Rye, Incorporated** – NOV #SW15-181/R2- For 1) causing or allowing sewage to overflow 3713 West Sahara Avenue, Las Vegas, Clark County, Nevada on or about February 18, 2015; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on February 25, 2015. *(for possible action)*

Hearing officer found Herbs and Rye, Incorporated in violation and imposed a penalty of \$900 for each of 1) and 2). Submission of a standard operating procedure for cleaning kitchen mats to ensure all wastewater generated is directed to the sanitary sewer via a grease interceptor is ordered.

- B. NON-CONTESTED NOTICES OF VIOLATION: The Hearing Officer may approve or disapprove the agreed resolution. Upon disapproval of the agreed resolution, the Hearing Officer will set a date for the hearing of any such Notice of Violations.

1. **Felix Ugalde** – NOV #SW15-578/G4- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about May 9, 2015; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located at the northeast corner of East Sahara Avenue and Louise Street, Clark County, Nevada on or about May 9, 2015. *(for possible action)*

Hearing officer found Felix Ugalde in violation of 2) and imposed a penalty of \$500. Corrective action of removal and proper disposal of waste is ordered. Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation.

2. **SGPS Holdings, LLC dba SGPS, Inc.** – NOV #SW15-421/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about April 1, 2015; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 2845 Coleman Street, North Las Vegas, Clark County, Nevada on or about April 1, 2015. *(for possible action)*

Hearing officer found SGPS Holdings, LLC dba SGPS, Inc. in violation of 2) and imposed a penalty of \$900. Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev.

3. **E & E Pools, LLC** – NOV #SW15-572/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on

or about May 14, 2015; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located west of 5285 North Chieftain Street, Clark County, Nevada on or about May 14, 2015. *(for possible action)*

Hearing officer found E & E Pools, LLC in violation of 2) and imposed a penalty of \$900. Cease and Desist order is issued to stop operating a solid waste disposal site without a permit from the solid waste management authority at this location or any other in Clark County, Nev. Failure to comply will result in the original penalty of \$1,800 as initially sought in the Notice of Violation.
