

## Public Health Update

Solid Waste Management Authority Hearing Officer Administrative Hearing - April 12, 2018

The Solid Waste Hearing Officer, under authority granted in Nevada Revised Statute (NRS) 444.629, conducts monthly hearings to settle cases involving illegal dumping and other solid waste matters. At the April 12, 2018 hearing, the following cases were adjudicated:

- I. MATTERS REQUIRING HEARING OFFICER ACTION MATTERS REQUIRING HEARING OFFICER ACTION
  - A. <u>NOTICES OF VIOLATION WITH CONTESTED FACTS</u>: None.
  - B. <u>NON-CONTESTED NOTICES OF VIOLATION</u>: The Hearing Officer may approve or disapprove the agreed resolution. Upon disapproval of the agreed resolution, the Hearing Officer will set a date for the hearing of any such Notice of Violations.
    - 1. **MJ Partners** NOV #SW17-1422/G4- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about November 3, 2017; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on December 18, 2017. *(for possible action)* 
      - Hearing officer found MJ Partners in violation of 2) and imposed a penalty of \$500. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.
    - 2. Sahara 250 Reno, LLC and Sahara Vanowen, LLC NOV #SW17-1426/V8- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about November 16, 2017; and 2) failure to comply with the Order issued by the Solid Waste Management Authority on December 19, 2017. (for possible action)

Hearing officer found Sahara 250 Reno, LLC and Sahara Vanowen in violation of 2) and imposed a penalty of \$500. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.

3. **Tyson Nathaniel Thayer** – NOV #SW18-008/H3- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about December 30, 2017; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 10600 Southern Highlands Parkway, Clark County, Nevada on or about December 30, 2017.

Hearing officer found Tyson Nathaniel Thayer in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purposes.

4. **Morris Shenker** – NOV #SW18-062/H3- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about January 21, 2018; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located at 355 North Gibson Road, Henderson, Clark County, Nevada on or about January 21, 2018. *(for possible action)* 

Hearing officer found Morris Shenker in violation of 2) and imposed a penalty of \$1,000. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purposes.

5. Angelica Jimenez and Jesus A. Jimenez dba Jesus Mobile Mix – NOV #SW18-067/C6-For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about January 21, 2018; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the vacant parcel located between West Hammer Lane and West Washburn Road on North Tee Pee Lane, Clark County, Nevada on or about January 21, 2018. (for possible action)

Hearing officer found Angelica Jimenez and Jesus A. Jimenez dba Jesus Mobile Mix in violation of 2) and imposed a penalty of \$1,000. Corrective action of removal and proper disposal of waste is ordered. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purposes. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.
