## SNHD Pediatric Early Warning Sentinel Surveillance (PEWSS) Report: August 29, 2012

## **General Update**

During the week ending August 25, 2012, the following viruses were identified through PEWSS with a low volume of testing (Fig. 1): Parainfluenza 2 and Parainfluenza 3.

Over the past five weeks (Tables 1 & 2), the following were identified in the community through PEWSS: Parainfluenza 3 has been circulating at low levels.

Adenovirus and Parainfluenza 2 have been sporadically identified.

Influenza A, Influenza B, Human Metapneumovirus, Parainfluenza 1 and RSV have not been identified.


