### NOTICES:

1. Nevada Revised Statutes (NRS) 241.020 requires that written notice of all hearings of the Southern Nevada Health District Board of Health's Office of Emergency Medical Services & Trauma System Hearing Officer be given at least three working days before the hearings. The notice shall include the time, place, location, and agenda of the hearing. Individuals may request notice, but a request for notice lapses six months after it is made. The Southern Nevada District Board of Health informs each requestor of this fact by this notation on the copy of the notice mailed to them.

#### A. APPEAL OF ORDER OF IMMEDIATE SUSPENSION:

1. **Treyveon Evans, License #108367** On September 6, 2022, the Southern Nevada Health District issued an order immediately suspending AEMT License #108367 after receiving documents indicating criminal charges were filed against the licensee for violation of NRS 201.300 (Case No. C-22-364515-1), that during the commission of the alleged crime the licensee endorsed theft from incapacitated persons, and that the licensee had not provided notification of same as required by EMS Regulation 1300.442. Mr. Evans appeals the basis for immediate suspension pursuant to EMS Regulation 1800.100(II).

IV.
