The notice shall include the time, place, location, and agenda of the hearing. Individuals may request notice, but a request for notice lapses six months after it is made. The Southern Nevada District Board of Health informs each requestor of this fact by this notation on the copy of the notice mailed to them.

3. **Silvereye Sustainability L.L.C.** – NOV #SW16-022/P9/P9- For failure to comply with the Order issued by the Solid Waste Management Authority Hearing Officer on September 8, 2016. (**for possible action**)

Proposed Penalties/ 1) \$1,400.00

Corrective Action: 2) Removal and proper disposal of waste.

3) Cease and desist operating a solid waste disposal site without a permit issued by the solid waste management authority at this location or anywhere else in Clark County, Nevada.

5) Implement written policies and procedures to prevent future illicit discharges of waste liquids.

6) Contract with a licensed liquid waste hauler to conduct routine service and pumping of the san-oil separator and the open pit on the northwest side of the building.
