

# **Public Health Update**

### Solid Waste Management Authority Hearing Officer Administrative Hearing - September 10, 2020

The Solid Waste Hearing Officer, under authority granted in Nevada Revised Statute (NRS) 444.629, conducts monthly hearings to settle cases involving illegal dumping and other solid waste matters. At the September 10, 2020 hearing, the following cases were adjudicated:

# I. MATTERS REQUIRING HEARING OFFICER ACTION

### A. <u>NOTICES OF VIOLATION WITH CONTESTED FACTS</u>:

 Justin A. Schafer – NOV #SW20-824/H3- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about January 7, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 4698 East Flamingo Road, Clark County, Nevada on or about January 7, 2020. (*for possible action*)

Haring officer found Justin A. Schafer in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit issued by the solid waste management authority at this location or anywhere else in Clark County, Nev. Failure to comply will result in the original penalty of \$2,000 as sought I the Notice of Violation.

 Flourishing Enterprises L.L.C. dba Vegas Best Auto Collision and Repair – NOV #SW20-226/C6 HOFTC- For failure to comply with the Order issued by the Solid Waste Management Authority Hearing Officer on February 13, 2020. (*for possible action*)

Whitney's Paw-Lished Pets Mobile Grooming, LLC – NOV #SW20-1194/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about February 7, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the private right of way located in front of 3184 Santolina Drive, Clark County, Nevada on or about February 7, 2020. *(for possible action)* 

Hearing officer found Whitney's Paw-Lished Pets Mobile Grooming, LLC in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit issued by the solid waste management authority at this location or anywhere else in Clark County, Nev. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.

4. Scruffy To Fluffy LV LLC – NOV #SW20-1195/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about February 14, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the private right of way located in front of 3201 Wisteria Tree Street, Clark County, Nevada on or about February 14, 2020. *(for possible action)*

5. **Blind Center of Nevada, Inc.** – NOV #SW20-1077/K5- For failure to submit an annual recycling survey to the Solid Waste Management Authority on or about February 18, 2020. *(for possible action)* 

Hearing officer found Blind Center of Nevada, Inc. in violation and imposed a penalty of \$500. Failure to comply will result in the initial penalty of \$1,000 as sought in the Notice of Violation.

6. Rebel Land and Development, LLC – NOV #SW20-1109/K5- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about February 25, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 901 North Buffalo Drive, Las Vegas, Clark County, Nevada on or about February 25, 2020. (*for possible action*)

(for possible action)

Hearing officer found Tammie Knight in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.

2. You Dirty Dog LLC – NOV #SW20-1196/C6- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about March 18, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the private right of way located in front of 3196 South Santolina Drive, Clark County, Nevada on or about March 18, 2020. *(for possible action)* 

Hearing officer found You Dirty Dog LLC in violation and imposed a penalty of \$1,000. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. Failure to comply will result I the original penalty of \$2,000 as initially sought in the Notice of Violation.
