

# **Public Health Update**

### Solid Waste Management Authority Hearing Officer Administrative Hearing – February 16, 2021

The Solid Waste Hearing Officer, under authority granted in Nevada Revised Statute (NRS) 444.629, conducts monthly hearings to settle cases involving illegal dumping and other solid waste matters. At the February 16, 2021, the following cases were adjudicated:

### I. MATTERS REQUIRING HEARING OFFICER ACTION

### A. <u>NOTICES OF VIOLATION WITH CONTESTED FACTS</u>:

1. **Marco A. Raya-Martinez** – NOV #SW21-343/G4- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about September 22, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the public right of way on the northeast corner of Mojave Avenue and Lucerne Street, Clark County, Nevada on or about September 22, 2020. *(for possible action)* 

Hearing officer found Marco A. Raya-Martinez in violation and imposed a penalty of \$1,000 for each for 1) and 2). A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit issued by the solid waste management authority at this location or anywhere else in Clark County, Nev.

2. **7-Eleven, Inc.** – NOV #SW21-136/H3- For failure to comply with the Order issued by the Solid Waste Management Authority on July 30, 2020. *(for possible action)* 

Hearing officer found 7-Eleven, Inc. in violation and imposed a penalty of \$500.

- B. <u>NON-CONTESTED NOTICES OF VIOLATION</u>: The Hearing Officer may approve or disapprove the agreed resolution. Upon disapproval of the agreed resolution, the Hearing Officer will set a date for the hearing of any such Notice of Violations.
  - 1. **Yosleidys Dominguez –** NOV #SW21-080/G4- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about July 19, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at Charleston Garden Apartments at 4860 East Charleston Boulevard, Las Vegas, Clark County, Nevada on or about July 19, 2020. *(for possible action)*

Hearing officer found Yosleidys Dominguez in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.

2. Yosleidys Dominguez – NOV #SW21-340/G4- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about September 11, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at Charleston Garden Apartments at 4860 East Charleston Boulevard, Las Vegas, Clark County, Nevada on or about September 11, 2020. (for possible action)

Hearing officer found Yosleidys Dominguez in violation of 2) and imposed a penalty of \$500. A Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.
