

Public Health Update

Solid Waste Management Authority Hearing Officer Administrative Hearing - June 10, 2021

The Solid Waste Hearing Officer, under authority granted in Nevada Revised Statute (NRS) 444.629, conducts monthly hearings to settle cases involving illegal dumping and other solid waste matters. At the June 10, 2021 the following cases were adjudicated:

- I. MATTERS REQUIRING HEARING OFFICER ACTION
 - A. NOTICES OF VIOLATION WITH CONTESTED FACTS:
 - 1. **Lazaro Ferran Aldana** NOV #SW21-374/56- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about September 26, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 4860 East Charleston Boulevard, Las Vegas, Clark County, Nevada on or about September 26, 2020. *(for possible action)*
 - Hearing officer found Lazar Ferran Aldana in violation and imposed a penalty of \$1,000 for each of 1) and 2). Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. A Cease and Desist order is issued to stop operating a solid waste disposal site without a permit issued by the solid waste management authority at this location or anywhere else in Clark County, Nev.
 - 2. **Nelson Eduardo Barrera** NOV #SW21-600/Z3- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about December 17, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 100 Wallace Drive, Las Vegas, Clark County, Nevada on or about December 17, 2020. *(for possible action)*
 - Item continued to July 8, 2021 hearing.
 - 3. **Dollar Tree Stores, Inc. –** NOV #SW21-601/C6- For failure to comply with the Order issued by the Solid Waste Management Authority on December 22, 2020. *(for possible action)*
 - Hearing officer found Dollar Tree Stores, Inc. in violation and imposed a penalty of \$500. Corrective action of removal and proper disposal of waste is ordered. Failure to comply will result in the original penalty of \$1,000 as initially sought in the Notice of Violation.

- B. <u>NON-CONTESTED NOTICES OF VIOLATION</u>: The Hearing Officer may approve or disapprove the agreed resolution. Upon disapproval of the agreed resolution, the Hearing Officer will set a date for the hearing of any such Notice of Violations.
 - 1. **Brandon Paulo** NOV #SW21-629/Z3- For 1) operating a disposal site in Clark County, Nevada, without a permit issued by the solid waste management authority on or about December 28, 2020; and 2) placing, depositing or dumping or causing to be placed, deposited or dumped solid waste upon the property located at 5050 Brent Lane, Las Vegas, Clark County, Nevada on or about December 28, 2020. *(for possible action)*

Hearing officer found Brandon Paulo in violation of 2) and imposed a penalty of \$500. Cease and Desist order is issued to stop placing, depositing, dumping or causing to be placed, deposited or dumped solid waste upon a property other than a property designated or set aside for such purpose is ordered. Failure to comply will result in the original penalty of \$2,000 as initially sought in the Notice of Violation.
